- 1 The legal basis for education in Tennessee is expressed in the state Constitution and state statutes, as  
2 interpreted by the courts.
- 3 The governing body of the school system shall be the Board of Education, serving residents within the  
4 boundaries of the school system and non-residents under conditions specified by state law and the  
5 Board.<sup>1</sup>
- 6 All powers of the Board lie in its action as a group; therefore, individual board members exercise their  
7 authority over school system affairs only as they vote to take action at an official board meeting.<sup>2</sup>
- 8 In other instances, an individual board member, including the Chair, shall have power only when  
9 specified by state law or when the Board, by vote, has delegated authority to him/her.

1 *General*

2 All school district budgets are the operational plans stated in financial terms for the fiscal year beginning  
3 July 1<sup>st</sup> ending June 30<sup>th</sup> the following year. <sup>1</sup>

4 *Central Office*

5 **BUDGET PREPARATION**

6 Budget planning shall include an analysis of previous staffing, curriculum and facilities, and projections  
7 requiring additional staffing, curriculum modifications, and additional facilities.

8 The budget proposal shall be balanced, consistent with board policy and contract conditions, and include  
9 provisions for:

- 10 1. Programs to meet the needs of the entire student body;
- 11
- 12 2. Staffing arrangements adequate for proposed programs;
- 13
- 14 3. Maintenance of the district's equipment and facilities; and
- 15
- 16 4. Efficiency and economy.

17 Budget preparation shall be the responsibility of the Director of Schools.<sup>2</sup> The Director of Schools will  
18 establish procedures for the involvement of staff, including requests from department heads and  
19 principals, all of whom shall seek advice and suggestions from other staff.

20 The Director of Schools and the Board Chair shall develop a budget preparation calendar no later than  
21 January 1<sup>st</sup>. The calendar shall be used as a guide for coordinating the budgetary activities of individuals  
22 and groups, collecting budget data, reviewing budget problems, and making budget decisions.

23 **HEARING AND REVIEWS**

24 The proposed budget will be available for inspection by various interested citizens or groups in the office  
25 of the Director of Schools.

**1 ADOPTION PROCEDURE**

- 2 The Board shall adopt a budget and submit it to the City Council. The Director of Schools shall file  
3 with the Commissioner of Education a copy of the budget within ten (10) days after its adoption.<sup>3</sup>

- 1 The Director of Schools shall develop procedures ensuring the useful life of equipment and supplies.
- 2 Equipment management shall be in accordance with federal and state laws, regulations, and guidelines.<sup>1</sup>
- 3 Employees of the district are responsible for the materials, equipment, and supplies assigned to them.
- 4 In addition, employees are responsible for the reasonable preservation and protection of materials,
- 5 equipment, and supplies not under their direct control.
