ESSER 3.0 Public Plan for Remaining Funds Addendum Guidance

2022-23

Local educational agencies (LEAs) are required to update the ESSER 3.0 Public Plan every six months through Sept. 30, 2023. Each time, LEAs must seek public input on the plan and any revisions and must take such input into account.

Each LEA must complete the addendum and upload it to ePlan in the LEA Document Library (Feb. 15 and Sept. 15). The LEA must also post the addendum to the LEA's website. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website. The plan intends to provide transparency to stakeholders.

Please consider the following when completing the addendum:

- On the summary page, the amounts should total the carryover amount for FY23 for each relief fund: ESSER 2.0, and ESSER 3.0.
- The LEA must respond to all questions in the document.
- The stakeholder engagement responses should closely align with the stakeholder engagement in the Health and Safety Plan.
- The LEA should ensure it uses multiple models of engagement offered to stakeholders. Examples may include surveys, in-person or virtual committee meetings, town hall meetings, or other inclusive engagement opportunities.
- LEAs should engage all applicable groups noted in meaningful consultation during the crafting of the plan and when making any significant revisions or updates to the plan.
- The number of stakeholders engaged should represent the composition of students. For example, if students with disabilities make up 15 percent of students, then 10-20 percent of respondents should represent this subgroup.
- Ensure the stakeholder engagement happened prior to the development/revision of the plan.
- Plans require local board approval and public posting.

The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

ESSER 3.0 Public Plan for Remaining Funds

The Elementary and Secondary School Emergency Relief 3.0 (ESSER 3.0) Fund under the American Rescue Plan (ARP) Act of 2021, Public Law 117-2, was enacted on March 11, 2021. Funding provided to states and local educational agencies (LEAs) helps safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on the nation’s students.

In the fall of 2021, LEAs developed and made publicly available a *Public Plan - Federal Relief Spending*. All plans were developed with meaningful public consultation with stakeholder groups. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA’s publicly available website.

Academics

1. Describe strategic allocations to accelerate **Academic Achievement**, including how allocations support the investments identified in the district's needs assessment.

Learning Loss Coordinator will oversee learning loss related to the pandemic and oversee summer learning loss camps for students.

2. Describe initiatives included in the "other" category.

Morgan County Schools will adopt and purchase K-12 math curriculum in 2023. Allocation for science lab materials for high school and middle school classes and renewal of online reading intervention programs will be imperative to students' academic growth. TN All Corps funding for small group instruction to help students improve in grades 1-5 math and reading proficiency.

Student Readiness

1. Describe strategic allocations to support **Student Readiness** and the School-Related Supports necessary to access high-quality instruction, including how allocations support the investments identified in the district's needs assessment.

Personnel, therapy supplies/equipment, and transportation equipment for students with special needs will be purchased for students in Morgan County that need accommodations to ensure the best education for all our students. School nurses and guidance counseling assistants will be provided at every school to help provide physical, emotional, and mental health supports for all students and staff.

2. Describe initiatives included in the "other" category.

Assistants for career/tech classes and high school students will be provided to ensure students receive the assistance needed to be successful. Physical/mental health equipment for students that need accommodations with anxiety and/or attentiveness will be provided. Academic educational online curriculum will be purchased to ensure compliance with the School Safety and Removal Act.

Educators

1. Describe strategic allocations to **Recruit, Retain and Support Educators and School Personnel**, including how allocations support the investments identified in the district's needs assessment.

Teacher efficacy and retention are directly related to their perception of value and available supports. Investing in the positions of Academic Deans will be a fulcrum for educators and personnel as a resource for securing high quality, relevant Tier 1 curriculum supports; designating a school specific staff member to monitor and adjust interventions based on student needs; and providing professional development for teacher success.

2. Describe initiatives included in the "other" category.

Academic Deans will provide assistance/support for teachers with data, standards, and teaching strategies. Additionally, Deans will supervise the grades 1-5 TN All Corps tutoring program. Assistant Principals will provide academic support as well as continued administrative duties related to the pandemic when necessary.

Foundations

1. Describe strategic allocations to **Strengthen Structural Expectations**, including how allocations support the investments identified in the district's needs assessment.

Morgan County Schools will strategically replace carpet flooring at schools with tile to improve air quality. A district wide technology coach will be available to assist students and faculty with technology needs related to academics.

Monitoring, Auditing, and Reporting

1. Outline how the LEA is continuing to actively monitor allocations; conducting interim audits to ensure an appropriate application of funds; collecting and managing data elements required to be reported; and reporting this information to the community.

The ESSER Grants Coordinator will do regular reviews and provide updated information to the Director of Schools and Morgan County Board of Education. Other checks and balances will include requiring multiple departments to sign off on expenditure before orders are processed. All aspects of ESSER 3.0 spending will be done in conjunction with the Finance Director of Morgan County. Reimbursement requests will be reviewed by the ESSER Grants Coordinator, Director of School, and Morgan County Finance Director.

Data elements will be managed at the school level by Academic Deans. These deans will be responsible for ensuring that programs are scheduled and facilitated efficiently and that learning outcomes are documented. School level data related to learning loss will be reviewed periodically for effectiveness.

Family and Community Engagement

Morgan County Schools has sent surveys to and had an in person meeting for families, students, faculty/staff, and other stakeholders to ensure a variety of ideas are considering in ESSER spending. ESSER updates are given periodically and Morgan County School Board meetings. Additionally, any stakeholder may make suggestions/comments by emailing essercomments@mcsed.net.

2. Describe how the LEA engaged at minimum 10 percent of the total stakeholders engaged vs. responses received in the development of the revised plan.

Morgan County Schools received 273 survey responses. The greatest response was for providing quality instructional materials and providing additional faculty/staff for academics/health/safety needs. While Morgan County is addressing a variety of needs, these are the two largest areas of allocation for ESSER funding. The ESSER Public Presentation outlined for stakeholders ESSER allocations and provided an opportunity for feedback.

3. Describe how the LEA engaged a representation of a diverse population of stakeholders.

All parents/guardians, students, and Morgan County School employees were sent information to have input regarding ESSER spending. Additionally, Morgan County stakeholders (county commissioners, school board members, and other elected officials) were given invitation for input.

The director of schools shall develop an administrative procedure to establish a system of grading and assessment for evaluating and recording student progress and to measure student performance in conjunction with Board-adopted content standards for grades K-8. The grading/assessment system shall follow all applicable statutes, rules, and regulations of the State Board of Education. The grading/assessment system shall be uniform district-wide at comparable grade levels, except that the director of schools shall have the authority to establish and operate ungraded and/or unstructured classes in grades K-3 according to state rules and regulations.¹

The director of schools shall submit a copy of the grading, reporting and assessment systems to the Board before the system is implemented.³ These guidelines shall be communicated annually to students and parent(s)/guardian(s).¹

Conduct grades are based on behavior and shall not be deducted from scholastic grades.

This grading system shall be uniform throughout the school district for each grade.

The Morgan County School Board recognized that the concept of Standards-Based Grading is a method of aligning student assessment with state curriculum standards. This grading system gives teachers more information about the student's progress in meeting benchmarks or levels of mastery for each standard. 1 **CLASS RANKING**

3 The Calculation of the GPA is determined by dividing the sum of the quality points by the potential
4 credits. Credit given to all courses taken in high school is counted.

5

6 Class rank is calculated based on the weighted average of all courses taken in high school.

7 Students must be enrolled full-time at the home base school to be eligible for class ranking.

8

9 All grades earned in grades 9, 10, 11 and the Fall semester of grade 12 will be counted toward the
10 grade point average and the rank in the class.

11

12 To become a Valedictorian or Salutatorian, a student must be enrolled in the high school at least four
13 (4) of the seven (7) semesters preceding the final semester.

14

15 In the matter of a tie concerning GPA, Valedictorian will be determined by the highest ACT test score.
16 (if a tie still exists multiple Valedictorians will be recognized)

17

18 **TRANSFER GRADE CONVERSION**

19 It is the intent of the district to attain the numerical grade from a transfer school. When the numerical
20 grade is not provided, the following scale will be used to convert the letter grade that is provided (note
21 the alternate scale in the following section for college level courses):

26 **LOTTERY SCHOLARSHIPS³**

28 Each school counselor shall provide incoming freshmen with information on college core courses
29 required for lottery scholarships as well as necessary criteria (grade point average, ACT score, etc.)
30 that must be met in order to receive a scholarship.

32 Seniors may apply for the Tennessee HOPE Scholarship by completing the Free Applications for
33 Federal Student Aid (FAFSA). The FAFSA is available online at www.fafsa.ed.gov. Students shall be
34 made aware of all applicable FAFSA deadlines and encouraged to submit applications in a timely
35 manner.

2 Elementary school counselors shall explain the HOPE Scholarship and its requirements to their
3 students and impress upon them the benefits of making good grades.

5 **LOTTERY SCHOLARSHIP DAY**

7 Each school year, prior to scheduling courses for the following school year, schools teaching students
8 in grades 8-11 shall conduct a lottery scholarship day for students and their parents.⁴

1 *General*¹

2 The Director of Schools shall establish procedures to protect school property which shall include, but
3 not be limited to:

- 4 1. Closing and securing teacher work areas when left unattended or at the end of the day;
- 5 2. Denying students permission to use the classrooms, laboratories, gymnasiums, or other school
6 facilities or equipment without appropriate supervision;
- 7 3. Controlling the issuance of keys;
- 8 4. Developing programs that contribute to the proper care and use of school facilities and
9 equipment; and
- 10 5. Ensuring that equipment purchased with federal funds is managed as directed by federal law.²

11 The principal shall call law enforcement officials in cases involving illegal entry, building damage, theft,
12 or vandalism. The principal shall notify the Director of Schools as soon as practical, but no longer than
13 twenty-four (24) hours, after a case of vandalism, theft, building damage, and/or illegal entry. The
14 Director of Schools/designee is authorized to sign a criminal complaint and press charges. The Director
15 of Schools shall report all signing of such complaints to the Board.

16 **LAW ENFORCEMENT SERVICES¹ (if applicable)**

17 The Board may enter into collaborative partnerships with appropriate law enforcement agencies.
18 Partnerships may include, but not be limited to, education and recreational programs, delinquency
19 prevention, and mentoring initiatives.

20 The Board may enter into a memorandum of understanding (MOU) with the chief of a law enforcement
21 agency to provide school policing. The MOU shall address, at a minimum, the following issues:

- 22 1. Any school resource officer (SRO) assigned under the MOU shall be in compliance with all laws,
23 regulations, and rules of the Peace Officer Standards and Training Commission at the time of
24 assignment and remain compliant throughout his/her assignment.
- 25 2. As a condition of assignment, any SRO shall participate in forty (40) hours of basic training in
26 school policing within twelve (12) months of assignment. Every year thereafter, the SRO shall
27 participate in a minimum of sixteen (16) hours of training specific to school policing. All training
28 programs shall be approved by the Peace Officers Standards and Training Commission.³

- 1 3. Any SRO assigned under the MOU remains an employee of the law enforcement agency and is
2 subject to that agency’s direction, control, supervision, and discipline.
- 3 4. No SRO shall be assigned to a school, or continue in such an assignment, without the consent of
4 the Director of Schools.
- 5 5. In the event that more than one (1) SRO is assigned to a school district, the law enforcement
6 agency shall designate one (1) of the SROs as the senior SRO. The duties of the senior SRO shall
7 include, but not be limited to, the following:
- 8 a. Representing and carrying out the policies of the law enforcement agency assigning the
9 SROs;
- 10 b. Supervising the SROs in the performance of their duties;
- 11 c. Consulting with the Director of Schools regarding the best use of the available resources
12 for school policing; and
- 13 d. Resolving disputes between the SROs and students or staff members.
- 14 6. The MOU may be effective for any length of time, continuing until terminated by the parties, and
15 may contain any reasonable notice requirement for the termination of the MOU. However, the
16 MOU shall contain a provision allowing the Director of Schools to suspend the active
17 participation of any SROs in the event that the Director of Schools believes that such suspension
18 is best for the health, safety, or wellbeing of the students or staff members.

19 **CYBERSECURITY⁴**

20 The Director of Schools/designee shall develop an administrative procedure regarding the district’s
21 cybersecurity plan to identify cybersecurity risks, implement mitigation planning, and protect
22 cyberinfrastructure against cyberattacks and other cybersecurity threats and incidents.

1 *General*

2 No person shall, on the basis of sex, be excluded from participation in, be denied the benefits of, be
3 treated differently from another person, or otherwise be discriminated against in any athletic program of
4 the school. Equal athletic opportunities shall be provided for members of both sexes.¹ Student athletes
5 shall only be allowed to participate in athletic activities or events that align with the student's sex
6 indicated on his/her original birth certificate.² The Director of Schools/designee shall require the
7 parent/guardian to provide the student's original birth certificate prior to participation in any
8 interscholastic athletics. If the original birth certificate is not available or does not indicate the student's
9 sex at the time of birth, the parent/guardian shall provide medical documentation showing evidence of
10 the student's sex at birth.

11 Interscholastic athletics shall be administered as a part of the regular school program and shall be the
12 principal's responsibility. Principals shall ensure that school regulations regarding participation in a sport
13 are reasonable. Athletic schedules shall be filed in each principal's office. The principal/designee shall
14 accompany an athletic team on trips. Transportation of teams to athletic games is approved by the Board,
15 provided the team's school reimburses the Board for mileage.

16 Bylaws of the Tennessee Secondary School Athletic Association shall regulate the operation and control
17 of athletics.³ The Director of Schools shall develop a code of conduct for all coaches to follow in order
18 to ensure the health and safety of athletes.⁴

19 **INSURANCE & PHYSICAL EXAMINATIONS**

20 In the event that the school's insurance provider does not extend coverage to an athlete, the athlete shall
21 provide proof of independently secured catastrophic coverage and liability coverage, with the school
22 district as a named insured, of not less than the limits set forth in state law.⁵ It shall be the responsibility
23 of the parent(s)/guardian(s) to provide health and hospitalization insurance for all students participating
24 in interscholastic athletics.

25 Prior to participation in interscholastic athletics, every student shall complete an annual physical
26 examination.⁶ The parent(s)/guardian(s) of each student shall be responsible for covering the cost of the
27 examination, and these records shall be on file in the principal's office.

28 **SCHEDULING CONFLICTS**

29 No principal or teacher shall dismiss his/her school or any group of students for the purpose of attending
30 the practice of any interscholastic sport during the school day without written permission from the
31 Board.⁷ This does not prevent regular physical training lessons in the daily school program.

1 Students shall not be required to attend a school athletic event, or event related to participation on a
2 school athletic team, if the event is on an official school holiday, observed day of worship, or religious
3 holiday. The student's parent/guardian shall notify the coach in writing three (3) full school days prior
4 to the event.⁸

5 **SEVERE WEATHER⁴**

6 Severe weather is any type of weather that could impede the safety of any athlete by compromising the
7 playing conditions of the interscholastic sport. Severe weather includes, but is not limited to, thunder,
8 lightning, and extreme temperatures. When severe weather is forecasted, suspension of play shall be
9 discussed with all players, coaches, and officials, if applicable.

10 All coaches who oversee or participate in outdoor training, practice, or competition shall annually
11 complete a heat illness prevention course approved by the Tennessee Department of Health as well as
12 receive training on activity modifications based on environmental conditions.

13 **PROHIBITION AGAINST HAZING**

14 Coaches, employees, and volunteers of the school district shall not encourage, permit, condone, or
15 tolerate hazing activities.⁹

1 *General*¹

2 The Board shall operate an alternative program for students in grades seven through twelve (7-12) who
3 have been suspended or expelled from the regular school program.

4 An alternative program is a short-term intervention program designed to provide educational services
5 outside the regular school program for students who have been suspended or expelled. Alternative
6 programs may be located within the regular school or be a self-contained program within a school.
7 Alternative programs shall include, but are not limited to, the following: _____ [e.g. **night**
8 **school or in-school suspension**].

9 The alternative school and/or program shall be operated in accordance with state laws and the rules of
10 the State Board of Education, and instruction shall proceed as nearly as practicable in accordance with
11 the instructional program at the student's regular school. The Director of Schools shall develop
12 procedures that provide appropriate educational opportunities for all students assigned to the
13 alternative school or program. These educational opportunities shall adhere to Tennessee's academic
14 standards.²

15 **ASSIGNMENT**

16 Students who have been suspended for more than ten (10) days or expelled shall be assigned to the
17 alternative school or program if there is staff and space available.³ Availability of staff and space shall
18 be determined at the time the disciplinary decision is rendered. The Director of Schools/designee shall
19 make this determination by evaluating factors including, but not limited to, the following:

- 20 1. Level of supervision available;
21
22 2. Safety considerations; and
23
24 3. Type of infraction.

25 The Director of Schools/designee is not required to assign a student to the alternative school or program
26 if the student committed one of the following:

- 27 1. A zero tolerance offense;⁴ or
28
29 2. An offense of violence or threatened violence, or an offense that threatened the safety of other
30 students at the school, if the location of the alternative school or program is on the same grounds
31 as the school from which the student was disciplined.⁵

1 Consideration to assign these students to the alternative school or program will be determined by the
2 Director of Schools/designee on a case-by-case basis.

3 Prior to the assignment of the student to the alternative school or program, the Director of
4 Schools/designee shall provide written notice to the student's parent/guardian stating the reason for the
5 student's placement.⁶

6 Placement in an alternative education setting shall be reserved for students who significantly disrupt
7 the educational process. If a student has an active Individualized Education Plan, a 504 plan, or is
8 suspected of having a disability, all state and federal laws and rules and regulations related to special
9 education shall be followed. The Director of Schools/designee shall develop procedures regarding
10 placement of students in the program, taking into consideration the impact of exclusionary discipline
11 practices.⁷

12 The Director of Schools/designee shall monitor and regularly evaluate the academic progress of each
13 student enrolled in the alternative school.

14 **REMOVAL⁸**

15 A student may be removed from the alternative school or program if:

- 16 1. He/she violates the rules of the alternative school or program; or
- 17 18 2. He/she is not benefitting from the assignment and all interventions have been exhausted
19 unsuccessfully.

20 **ADDITIONAL OFFENSES⁹**

21 Any new disciplinary offense committed during a student's original suspension or expulsion period
22 shall be treated as a new and separate offense. These offenses shall not constitute an extension of the
23 original suspension or expulsion.

24 **TRANSITION PLAN¹⁰**

25 The Director of Schools/designee shall develop procedures regarding the implementation of transition
26 plans for the integration of students assigned to the alternative school.
