Pursuant to the requirements of the State of Tennessee's Open Meetings Act, codified at Tennessee Code Ann §8-44-101 et seq., the following is published and made known to all interested persons:

Tuesday, November 17, 2020 at 5:30 p.m., the Arlington Community Schools Board of Education will hold its Business Meeting to address board business.

Pursuant to Tennessee Governor Bill Lee's Executive Order No. 65, this meeting will be held by electronic means. This meeting will be videotaped and will be available for viewing on the Arlington Community Schools website by no later than November 19, 2020.

If you have any public comments to share with the Board, please submit your comments to [info@acsk-12.org](mailto:info@acsk-12.org) by no later than 5:00 p.m. on November 16, 2020. Your comment will be ready by the Board Secretary at the commencement of the meeting. However, in order for your comment to be read, it must comply with the following Board rule:

Pursuant to ACS Board Policy 1.404:

Public comments shall be limited to up to two (2) minutes per "public comment". At the discretion of the Chairman, limitations may be placed on the following: 1) a speaker's time to comment; 2) the number of speakers commenting on the same topic; and/or 3) the number of speakers representing the same group or organization.

The public comment must state the name of the person making the comment, the home address of the person making the comment, the organization that the person making the comment is representing, if any and the subject of the presentation for the public comment to be read. Speakers may offer objective comments about school operations and programs that concern them. Speakers are asked to refrain from using names of personnel or names of persons connected with the school system, particularly when lodging a complaint. The person making the comment will not be permitted to engage in gossip, make defamatory comments, or use abusive or vulgar language.
