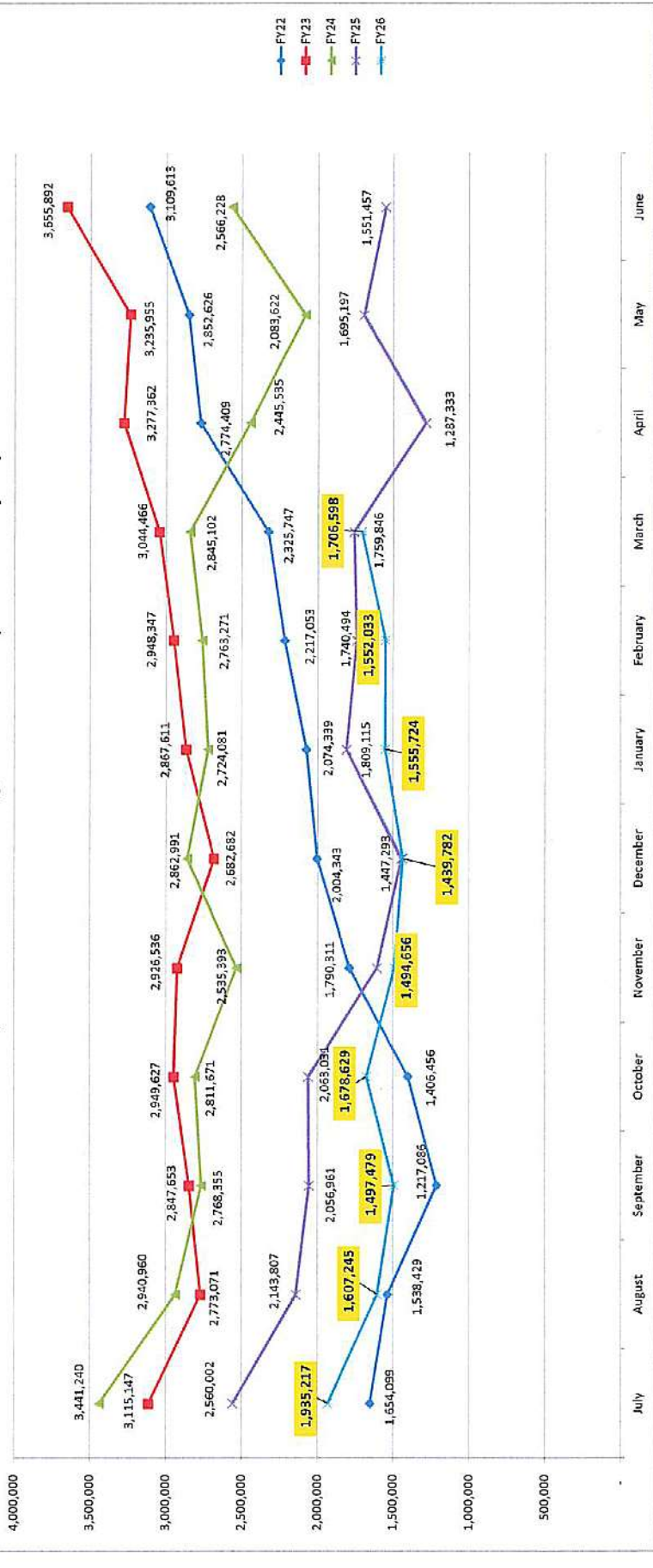

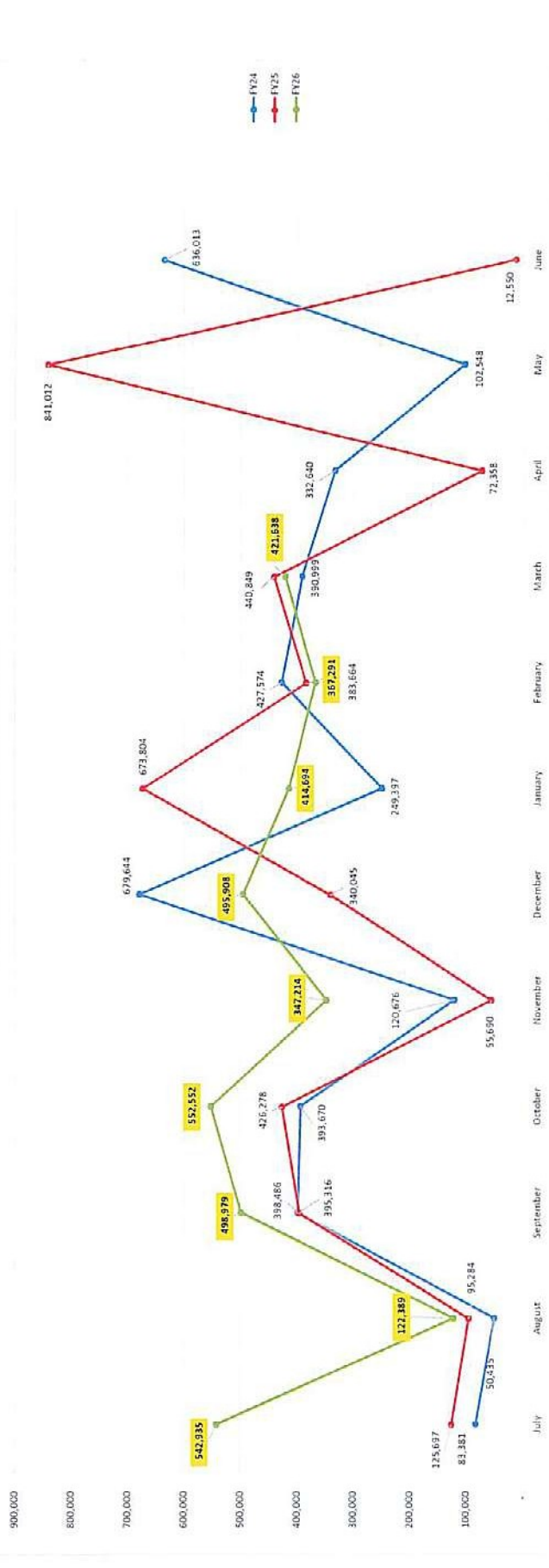

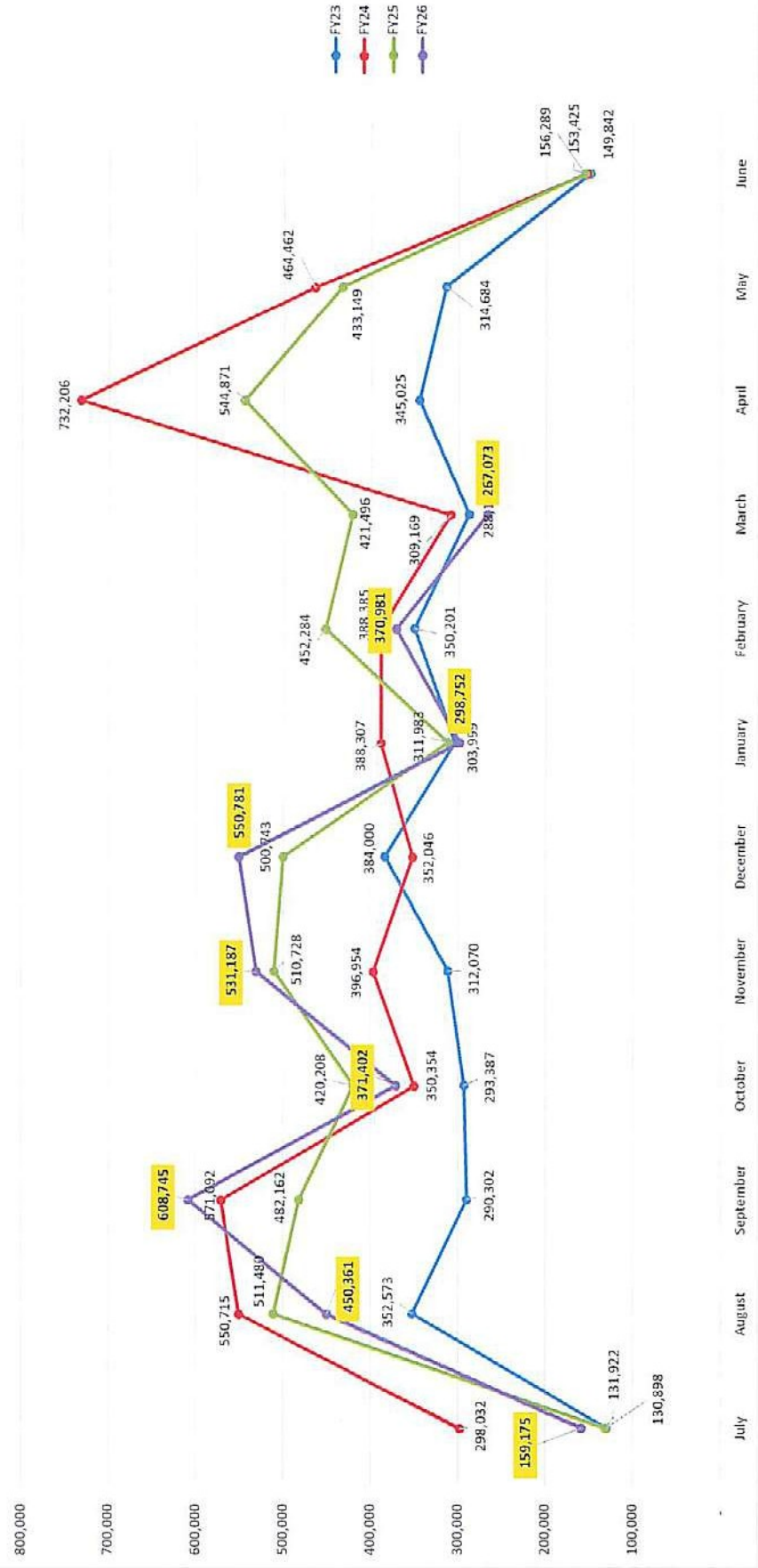
Dietary Revenue Trends FY23 Through FY26

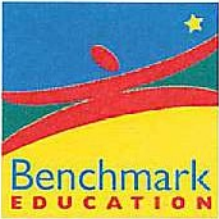

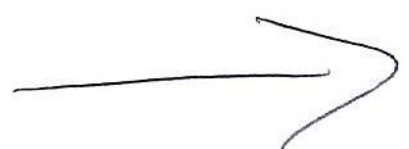

If the parties are both at fault, the obligation to indemnify shall be proportional to their relative fault. The duty to indemnify will continue in full force and effect, notwithstanding the expiration or early termination hereof, with respect to any claims based on facts or conditions that occurred prior to expiration or termination.

- 10. Insurance.** Upon request, Company will furnish evidence of its standard insurance coverage. If Customer has requested to be named as an additional insured under Company's insurance policy, Company will do so but only subject to Company's manuscript additional insured endorsement under its primary Commercial General Liability policies. In no event does Company waive any rights of subrogation.
- 11. Customer Breach.** Each of the following events or conditions shall constitute a breach by Customer and shall give Company the right, without an election of remedies, to terminate this Agreement, require payment prior to shipping, or suspend performance by delivery of written notice: (1) Any failure by Customer to pay amounts when due; (2) any general assignment by Customer for the benefit of its creditors, or if Customer becomes bankrupt or insolvent or takes the benefit of any statute for bankrupt or insolvent debtors, or makes or proposes to make any proposal or arrangement with creditors, or if any steps are taken for the winding up or other termination of Customer or the liquidation of its assets, or if a trustee, receiver, or similar person is appointed over any of the assets or interests of Customer; (3) Any representation or warranty furnished by Customer in connection with this Agreement is false or misleading in any material respect when made; or (4) Any failure by Customer to perform or comply with any material provision of this Agreement. Customer shall be liable to the Company for all Equipment furnished and all damages sustained by Company (including lost profit and overhead).
- 12. Limitation of Liability. NOTWITHSTANDING ANYTHING TO THE CONTRARY, IN NO EVENT SHALL COMPANY BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT CONSEQUENTIAL, PUNITIVE, EXEMPLARY DAMAGES (INCLUDING WITHOUT LIMITATION REFRIGERANT LOSS, BUSINESS INTERRUPTION, LOST DATA, LOST REVENUE, LOST PROFITS), OR CONTAMINANTS LIABILITIES, EVEN IF A PARTY HAS BEEN ADVISED OF SUCH POSSIBLE DAMAGES OR IF SAME WERE REASONABLY FORESEEABLE AND REGARDLESS OF WHETHER THE CAUSE OF ACTION IS FRAMED IN CONTRACT, NEGLIGENCE, ANY OTHER TORT, WARRANTY, STRICT LIABILITY, OR PRODUCT LIABILITY. In no event will Company's liability in connection with the provision of products or services or otherwise under this Agreement exceed the entire amount paid to Company by Customer under this Agreement.**
- 13. CONTAMINANTS LIABILITY**
The transmission of COVID-19 may occur in a variety of ways and circumstances, many of the aspects of which are currently not known. HVAC systems, products, services and other offerings have not been tested for their effectiveness in reducing the spread of COVID-19, including through the air in closed environments. **(IN NO EVENT WILL COMPANY BE LIABLE UNDER THIS AGREEMENT OR OTHERWISE FOR ANY INDEMNIFICATION, ACTION, OR CLAIM, WHETHER BASED ON WARRANTY, CONTRACT, TORT OR OTHERWISE, FOR ANY BODILY INJURY (INCLUDING DEATH), DAMAGE TO PROPERTY, OR ANY OTHER LIABILITIES, DAMAGES OR COSTS RELATED TO CONTAMINANTS (INCLUDING THE SPREAD, TRANSMISSION, MITIGATION, ELIMINATION, OR CONTAMINATION THEREOF) (COLLECTIVELY, "CONTAMINANTS LIABILITIES") AND CUSTOMER HEREBY EXPRESSLY RELEASES COMPANY FROM ANY SUCH CONTAMINANTS LIABILITIES.**
- 14. Nuclear Liability.** In the event that the Equipment sold hereunder is to be used in a nuclear facility, Customer will, prior to such use, arrange for insurance or governmental indemnity protecting Company against all liability and hereby releases and agrees to indemnify Company and its suppliers for any nuclear damage, including loss of use, in any manner arising out of a nuclear incident, whether alleged to be due, in whole or in part to the negligence or otherwise of Company or its suppliers.
- 15. Intellectual Property; Patent Indemnity.** Company retains all ownership, license and other rights to all patents, trademarks, copyrights, trade secrets and other intellectual property rights related to the Equipment, and, except for the right to use the Equipment sold, Customer obtains no rights to use any such intellectual property. Company agrees to defend any suit or proceeding brought against Customer so far as such suit or proceeding is solely based upon a claim that the use of the Equipment provided by Company constitutes infringement of any patent of the United States of America, provided Company is promptly notified in writing and given authority, information and assistance for defense of same. Company will, at its option, procure for Customer the right to continue to use said Equipment, or modify it so that it becomes non-infringing, or replace same with non-infringing Equipment, or to remove said Equipment and to refund the purchase price. The foregoing will not be construed to include any Agreement by Company to accept any liability whatsoever in respect to patents for inventions including more than the Equipment furnished hereunder, or in respect of patents for methods and processes to be carried out with the aid of said Equipment. The provision of Equipment by Company does not convey any license, by implication, estoppel, or otherwise, under patent claims covering combinations of said Equipment with other devices or elements. The foregoing states the entire liability of Company with regard to patent infringement. Notwithstanding the provisions of this paragraph, Customer will hold Company harmless against any expense or loss resulting from infringement of patents or trademarks arising from compliance with Customer's designs or specifications or instructions.
- 16. Cancellation.** Equipment is specially manufactured in response to orders. An order placed with and accepted by Company cannot be delayed, canceled, suspended, or extended except with Company's written consent and upon written terms accepted by Company that will reimburse Company for and indemnify Company against loss and provide Company with a reasonable profit for its materials, time, labor, services, use of facilities and otherwise. Customer will be obligated to accept any Equipment shipped, tendered for delivery or delivered by Company pursuant to the order prior to any agreed delay, cancellation, suspension or extension of the order. Any attempt by Customer to unilaterally revoke, delay or suspend acceptance for any reason whatever after it has agreed to delivery of or accepted any shipment shall constitute a breach of this Agreement. For purposes of this paragraph, acceptance occurs by any waiver of inspection, use or possession of Equipment, payment of the invoice, or any indication of exclusive control exercised by Customer.
- 17. Invoicing and Payment.** Unless otherwise agreed to in writing by Company, equipment shall be invoiced to Customer upon tender of delivery thereof to the carrier. Customer shall pay Company's invoices within net 30 days of shipment date. Company reserves the right to add to any account outstanding for more than 30 days a service charge equal to the lesser of the maximum allowable legal interest rate or 1.5% of the principal amount due at the end of each month. Customer shall pay all costs (including attorneys' fees) incurred by Company in attempting to collect amounts due and otherwise enforcing these terms and conditions. If requested, Company will provide appropriate lien waivers upon receipt of payment. Company may at any time decline to ship, make delivery or perform work except upon receipt of cash payment, letter of credit, or security, or upon other terms and conditions satisfactory to Company. Customer agrees that, unless Customer makes payment in advance, Company will have a purchase money security interest in all Equipment to secure payment in full of all amounts due Company and its order for the Equipment, together with these terms and conditions, form a security agreement (as defined by the UCC in the United States and as defined in the Personal Property Security Act in Canada). Customer shall keep the Equipment free of all taxes and encumbrances, shall not remove the Equipment from its original installation point and shall not assign or transfer any interest in the Equipment until all payments due Company have been made. The purchase money security interest granted herein attaches upon Company's acceptance of Customer's order and on receipt of the Equipment described in the accepted Proposal but prior to its installation. The parties have no agreement to postpone the time for attachment unless specifically noted in writing on the accepted order. Customer will have no rights of set off against any amounts, which become payable to Company under this Agreement or otherwise.
- 18. Claims.** Company will consider claims for concealed shortages in shipments or rejections due to failure to conform to an order only if such claims or rejections are made in writing within 15 days of delivery and are accompanied by the packing list and, if applicable, the reasons in detail why the Equipment does not conform to Customer's order. Upon receiving authorization and shipping instructions from authorized personnel of Company, Customer may return rejected Equipment, transportation charges prepaid, for replacement. Company may charge Customer any costs resulting from the testing, handling, and disposition of any Equipment returned by Customer which are not found by Company to be nonconforming. All Equipment damaged during shipment and all claims relating thereto must be made with the freight carrier in accordance with such carrier's policies and procedures. Claims for Equipment damaged during shipment are not covered under the warranty provision stated herein.
- 19. Export Laws.** The obligation of Company to supply Equipment under this Agreement is subject to the ability of Company to supply such items consistent with applicable laws and regulations of the United States and other governments. Company reserves the right to refuse to enter into or perform any order, and to cancel any order, under this Agreement if Company in its sole discretion determines that performance of the transaction to which such order relates would violate any such applicable law or regulation. Customer will pay all handling and other similar costs from Company's factories including the costs of freight, insurance, export clearances, import duties and taxes. Customer will be "exporter of record" with respect to any export from the United States of America and will perform all compliance and logistics functions in connection therewith and will also comply with all applicable laws, rules and regulations. Customer understands that Company and/or the Equipment are subject to laws and regulations of the United States of America which may require licensing or authorization for and/or prohibit export, re-export or diversion of Company's Equipment to certain countries, and agrees it will not knowingly assist or participate in any such diversion or other violation of applicable United States of America laws and regulations. Customer agrees to hold harmless and indemnify Company for any damages resulting to Customer or Company from a breach of this paragraph by Customer.
- 20. General.** Except as provided below, to the maximum extent provided by law, this Agreement is made and shall be interpreted and enforced in accordance with the laws of the state of New York for Equipment shipped to a U.S. location and the laws of the province to which Equipment is shipped within Canada, without regard to its conflict of law principles that might otherwise call for the application of a different state's or province's law, and not including the United Nations Convention on Contracts for the International Sale of Goods. To the extent the Equipment is being used at a site owned and/or operated by any agency of the Federal Government, determination of any substantive issue of law shall be according to the Federal common law of Government contracts as enunciated and applied by Federal judicial bodies and boards of contract appeals of the Federal Government. This Agreement contains all of the agreements, representations and understandings of the parties and supersedes all previous understandings, commitments or agreements, oral or written, related to the subject matter hereof. This Agreement may not be amended, modified or terminated except by a writing signed by the parties hereto. No documents shall be incorporated herein by reference except to the extent Company is a signatory thereon. If any term or condition of this Agreement is invalid, illegal or incapable of being enforced by any rule of law, all other terms and conditions of this Agreement will nevertheless remain in full force and effect as long as the economic or legal substance of the transaction contemplated hereby is not affected in a manner adverse to any party hereto. Customer may not assign, transfer, or convey this Agreement, or any part hereof, or its right, title or interest herein, without the written consent of the Company. Subject to the foregoing, this Agreement shall be binding upon and inure to the benefit of Customer's permitted successors and assigns. This Agreement may be executed in several

counterparts, each of which when executed shall be deemed to be an original, but all together shall constitute but one and the same Agreement. A fully executed facsimile copy hereof or the several counterparts shall suffice as an original.

21. Federal Requirements. The Parties shall comply with all United States federal labor law obligations under 29 CFR part 471, appendix A to subpart A. THE FOLLOWING PROVISIONS ARE INCORPORATED HEREIN BY REFERENCE: Executive Order 11701 and 41 CFR §§ 60-250.5(a), 60-300.5; Executive Order 11758 and 41 CFR § 60-741.5(a); U.S. Immigration laws, including the L-1 Visa Reform Act of 2004 and the H-1B Visa Reform Act of 2004; and Executive Order 13496. The Parties shall abide by the requirements of 41 CFR 60-300.5(a) and 60-741.5(a). These regulations prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities. Moreover, these regulations require that covered prime contractors and subcontractors take affirmative action to employ and advance in employment individuals without regard to protected veteran status or disability. The Parties certify that they do not operate any programs promoting DEI that violate any applicable United States anti-discrimination laws and acknowledge and agree that their compliance with all applicable federal anti-discrimination laws is material to the federal government's payment decisions. The Parties acknowledge and agree that their employment, procurement, and contracting practices shall not consider race, color, sex, sexual preference, religion, or national origin in ways that violate United States federal civil rights laws.

22. U.S. Government Work.

The following provision applies only to direct sales by Company to the US Government. The Parties acknowledge that Equipment ordered and delivered under this Agreement are Commercial Items as defined under Part 12 of the Federal Acquisition Regulation (FAR). In particular, Company agrees to be bound only by those Federal contracting clauses that apply to "commercial" suppliers and that are contained in FAR 52.212-5(e)(1).

The following provision applies only to indirect sales by Company to the US Government. As a Commercial Item Subcontractor, Company accepts only the following mandatory flow down provisions: 52.219-8; 52.222-26; 52.222-35; 52.222-36; 52.222-39; 52.247-84. If the sale of the Equipment is in connection with a U.S. Government contract, Customer certifies that it has provided and will provide current, accurate, and complete information, representations and certifications to all government officials, including but not limited to the contracting officer and officials of the Small Business Administration, on all matters related to the prime contract, including but not limited to all aspects of its ownership, eligibility, and performance. Anything herein notwithstanding, Company will have no obligations to Customer unless and until Customer provides Company with a true, correct and complete executed copy of the prime contract. Upon request, Customer will provide copies to Company of all requested written communications with any government official related to the prime contract prior to or concurrent with the execution thereof, including but not limited to any communications related to Customer's ownership, eligibility or performance of the prime contract. Customer will obtain written authorization and approval from Company prior to providing any government official any information about Company's performance of the work that is the subject of the Proposal or this Agreement, other than the Proposal or this Agreement.

23. Limited Waiver of Sovereign Immunity. If Customer is an Indian tribe (in the U.S.) or a First Nation or Band Council (in Canada), Customer, whether acting in its capacity as a government, governmental entity, a duly organized corporate entity or otherwise, for itself and for its agents, successors, and assigns: (1) hereby provides this limited waiver of its sovereign immunity as to any damages, claims, lawsuit, or cause of action (herein "Action") brought against Customer by Company and arising or alleged to arise out of the furnishing by Company of any product or service under this Agreement, whether such Action is based in contract, tort, strict liability, civil liability or any other legal theory; (2) agrees that jurisdiction and venue for any such Action shall be proper and valid (a) if Customer is in the U.S., in any state or United States court located in the state in which Company is performing this Agreement or (b) if Customer is in Canada, in the superior court of the province or territory in which the work was performed; (3) expressly consents to such Action, and waives any objection to jurisdiction or venue; (4) waives any requirement of exhaustion of tribal court or administrative remedies for any Action arising out of or related to this Agreement; and (5) expressly acknowledges and agrees that Company is not subject to the jurisdiction of Customer's tribal court or any similar tribal forum, that Customer will not bring any action against Company in tribal court, and that Customer will not avail itself of any ruling or direction of the tribal court permitting or directing it to suspend its payment or other obligations under this Agreement. The individual signing on behalf of Customer warrants and represents that such individual is duly authorized to provide this waiver and enter into this Agreement and that this Agreement constitutes the valid and legally binding obligation of Customer, enforceable in accordance with its terms.

SECURITY ADDENDUM

This Addendum shall be applicable to the sale, installation and use of Trane equipment and the sale and provision of Trane services. "Trane" shall mean Trane U.S. Inc. for sales and services in the United States, or Trane Canada ULC for sales and services in Canada.

1. **Definitions.** All terms used in this Addendum shall have the meaning specified in the Agreement unless otherwise defined herein. For the purposes of this Addendum, the following terms are defined as follows:
"Customer Data" means Customer account information as related to the Services only and does not include HVAC Machine Data or personal data. Trane does not require, nor shall Customer provide personal data to Trane under the Agreement. Such data is not required for Trane to provide its Equipment and/or Services to the Customer.
"Equipment" shall have the meaning set forth in the Agreement.
"HVAC Machine Data" means data generated and collected from the product or furnished service without manual entry. HVAC Machine Data is data relating to the physical measurements and operating conditions of a HVAC system, such as but not limited to, temperatures, humidity, pressure, HVAC equipment status. HVAC Machine Data does not include Personal Data and, for the purposes of this agreement, the names of users of Trane's controls products or hosted applications shall not be Personal Data, if any such user chooses to use his/her name(s) in the created accounts within the controls product (e.g., firstname.lastname@address.com). HVAC Machine Data may be used by Trane: (a) to provide better support services and/or products to users of its products and services; (b) to assess compliance with Trane terms and conditions; (c) for statistical or other analysis of the collective characteristics and behaviors of product and services users; (d) to backup user and other data or information and/or provide remote support and/or restoration; (e) to provide or undertake: engineering analysis; failure analysis; warranty analysis; energy analysis; predictive analysis; service analysis; product usage analysis; and/or other desirable analysis, including, but not limited to, histories or trends of any of the foregoing; and (f) to otherwise understand and respond to the needs of users of the product or furnished service. **"Personal Data"** means data and/or information that is owned or controlled by Customer, and that names or identifies, or is about a natural person, such as: (i) data that is explicitly defined as a regulated category of data under any data privacy laws applicable to Customer; (ii) non-public personal information ("NPI") or personal information ("PI"), such as national identification number, passport number, social security number, social insurance number, or driver's license number; (iii) health or medical information, such as insurance information, medical prognosis, diagnosis information, or genetic information; (iv) financial information, such as a policy number, credit card number, and/or bank account number; (v) personally identifying technical information (whether transmitted or stored in cookies, devices, or otherwise), such as IP address, MAC address, device identifier, International Mobile Equipment Identifier ("IMEI"), or advertising identifier; (vi) biometric information; and/or (vii) sensitive personal data, such as, race, religion, marital status, disability, gender, sexual orientation, geolocation, or mother's maiden name.
"Security Incident" shall refer to (i) a compromise of any network, system, application or data in which Customer Data has been accessed or acquired by an unauthorized third party; (ii) any situation where Trane reasonably suspects that such compromise may have occurred; or (iii) any actual or reasonably suspected unauthorized or illegal Processing, loss, use, disclosure or acquisition of or access to any Customer Data.
"Services" shall have the meaning set forth in the Agreement.
2. **HVAC Machine Data; Access to Customer Extranet and Third Party Systems.** If Customer grants Trane access to HVAC Machine Data via web portals or other non-public websites or extranet services on Customer's or a third party's website or system (each, an "Extranet"), Trane will comply with the following:
 - a. **Accounts.** Trane will ensure that Trane's personnel use only the Extranet account(s) designated by Customer and will require Trane personnel to keep their access credentials confidential.
 - b. **Systems.** Trane will access the Extranet only through computing or processing systems or applications running operating systems managed by Trane that include: (i) system network firewalls; (ii) centralized patch management; (iii) operating system appropriate anti-malware software; and (iv) for portable devices, full disk encryption.
 - c. **Restrictions.** Unless otherwise approved by Customer in writing, Trane will not download, mirror or permanently store any HVAC Machine Data from any Extranet on any medium, including any machines, devices or servers.
 - d. **Account Termination.** Trane will terminate the account of each of Trane's personnel in accordance with Trane's standard practices after any specific Trane personnel who has been authorized to access any Extranet (1) no longer needs access to HVAC Machine Data or (2) no longer qualifies as Trane personnel (e.g., the individual leaves Trane's employment).
 - e. **Third Party Systems.** Trane will provide Customer prior notice before it uses any third party system that stores or may otherwise have access to HVAC Machine Data, unless (1) the data is encrypted and (2) the third party system will not have access to the decryption key or unencrypted "plain text" versions of the HVAC Machine Data.
3. **Customer Data; Confidentiality.** Trane shall keep confidential, and shall not access or use any Customer Data and information that is marked confidential or by its nature is considered confidential ("Customer Confidential Information") other than for the purpose of providing the Equipment and Services, and will disclose Customer Confidential Information only: (i) to Trane's employees and agents who have a need to know to perform the Services, (ii) as expressly permitted or instructed by Customer, or (iii) to the minimum extent required to comply with applicable law, provided that Trane (1) provides Customer with prompt written notice prior to any such disclosure, and (2) reasonably cooperate with Customer to limit or prevent such disclosure.
4. **Customer Data; Compliance with Laws.** Trane agrees to comply with laws, regulations governmental requirements and industry standards and practices relating to Trane's processing of Customer Confidential Information (collectively, "Laws").
5. **Customer Data; Information Security Management.** Trane agrees to establish and maintain an Information security and privacy program, consistent with applicable HVAC equipment industry practices that complies with this Addendum and applicable Laws ("**Information Security Program**"). The Information Security Program shall include appropriate physical, technical and administrative safeguards, including any safeguards and controls agreed by the Parties in writing, sufficient to protect Customer systems, and Customer's Confidential Information from unauthorized access, destruction, use, modification or disclosure. The Information Security Program shall include appropriate, ongoing training and awareness programs designed to ensure that Trane's employees and agents, and others acting on Trane's, behalf are aware of and comply with the Information Security Program's policies, procedures, and protocols.
6. **Monitoring.** Trane shall monitor and, at regular intervals consistent with HVAC equipment industry practices, test and evaluate the effectiveness of its Information Security Program. Trane shall evaluate and promptly adjust its Information Security Program in light of the results of the testing and monitoring, any material changes to its operations or business arrangements, or any other facts or circumstances that Trane knows or reasonably should know may have a material impact on the security of Customer Confidential Information, Customer systems and Customer property.
7. **Audits.** Customer acknowledges and agrees that the Trane SOC2 audit report will be used to satisfy any and all audit/inspection requests/requirements by or on behalf of Customer. Trane will make its SOC2 audit report available to Customer upon request and with a signed nondisclosure agreement.
8. **Information Security Contact.** Trane's Information security contact is Local Sales Office.
9. **Security Incident Management.** Trane shall notify Customer after the confirmation of a Security Incident that affects Customer Confidential Information, Customer systems and Customer property. The written notice shall summarize the nature and scope of the Security Incident and the corrective action already taken or planned.
10. **Threat and Vulnerability Management.** Trane regularly performs vulnerability scans and addresses detected vulnerabilities on a risk basis. Periodically, Trane engages third-parties to perform network vulnerability assessments and penetration testing. Vulnerabilities will be reported in accordance with Trane's cybersecurity vulnerability reported process. Trane periodically provides security updates and software upgrades.
11. **Security Training and Awareness.** New employees are required to complete security training as part of the new hire process and receive annual and targeted training (as needed and appropriate to their role) thereafter to help maintain compliance with Security Policies, as well as other corporate policies, such as the Trane Code of Conduct. This includes requiring Trane employees to annually re-acknowledge the Code of Conduct and other Trane policies as appropriate. Trane conducts periodic security awareness campaigns to educate personnel about their responsibilities and provide guidance to create and maintain a secure workplace.

12. **Secure Disposal Policies.** Trane will maintain policies, processes, and procedures regarding the disposal of tangible and intangible property containing Customer Confidential Information so that wherever possible, Customer Confidential Information cannot be practicably read or reconstructed.
13. **Logical Access Controls.** Trane employs internal monitoring and logging technology to help detect and prevent unauthorized access attempts to Trane's corporate networks and production systems. Trane's monitoring includes a review of changes affecting systems' handling authentication, authorization, and auditing, and privileged access to Trane production systems. Trane uses the principle of "least privilege" (meaning access denied unless specifically granted) for access to customer data.
14. **Contingency Planning/Disaster Recovery.** Trane will implement policies and procedures required to respond to an emergency or other occurrence (i.e. fire, vandalism, system failure, natural disaster) that could damage Customer Data or any system that contains Customer Data. Procedures include the following
 - (i) Data backups; and
 - (ii) Formal disaster recovery plan. Such disaster recovery plan is tested at least annually.
15. **Return of Customer Data.** If Trane is responsible for storing or receiving Customer Data, Trane shall, at Customer's sole discretion, deliver Customer Data to Customer in its preferred format within a commercially reasonable period of time following the expiration or earlier termination of the Agreement or, such earlier time as Customer requests, securely destroy or render unreadable or undecipherable each and every original and copy in every media of all Customer's Data in Trane's possession, custody or control no later than [90 days] after receipt of Customer's written instructions directing Trane to delete the Customer Data.
16. **Background Checks** Trane shall take reasonable steps to ensure the reliability of its employees or other personnel having access to the Customer Data, including the conducting of appropriate background and/or verification checks in accordance with Trane policies.
17. **DISCLAIMER OF WARRANTIES.** EXCEPT FOR ANY APPLICABLE WARRANTIES IN THE AGREEMENT, THE SERVICES ARE PROVIDED "AS IS", WITH ALL FAULTS, AND THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY AND EFFORT AS TO SUCH SERVICES SHALL BE WITH CUSTOMER. 1. Description of Data:

Data will be shared in relation to the ETSU GEAR UP grant. Recipient is the prime awardee, and the grant has been awarded by the U.S. Department of Education.

The data points included in Exhibit A to this Data Transfer and Use Agreement will be transferred to Recipient and to third-party entity Vela Institute. Provider will provide data relating to students attending its schools. Provider will create export reports and will provide the data following this collection schedule: September, January, and June for each year of the grant program.

Provider will also share sign-in sheets for all GEAR UP activities as well as a yearly list of high school graduates from GEAR UP schools, including First Name, Last Name, and Date of Birth.

Provider will also collaborate with Recipient to administer surveys to students relating to pre-treatment college knowledge and pre-treatment FAFSA completions and college applications. These surveys will be administered through Qualtrics and will be shared for completion at least annually.

2. Description of Project:

The GEAR UP program provides financial and academic assistance and support, mentoring, and outreach to students with an aim to increase the number of low-income and first-generation students who are prepared to enroll and succeed in college. ETSU GEAR UP will serve 5,198 students in six low income Local Education Agencies (LEAs) across East TN during the seven-year grant period. Services will be provided to two cohorts of students. ETSU GEAR UP's project design is Think, Know, Act, Go: Educational Attainment and Economic Mobility. The design is grounded in the seminal college readiness work of David Conley. Adapting Conley's framework, four themes guide implementation and services: College-Going Culture (Think), Financial Literacy (Know), Academic Advising (Act), Postsecondary and Career Preparation (Go). ETSU GEAR UP provides required and permissible activities: tutoring, academic advising and counseling, dual-enrollment, college planning and financial aid workshops, mentoring, college visits, summer programming, non-cognitive skill development, financial literacy, college transition support to 7th year cohort students, and professional development to educators.

A collaborative evaluation approach with Vela Institute and ETSU research faculty will produce high quality evaluation. To meet project objectives, ETSU GEAR UP will use data to guide services, maximizing project effectiveness in meeting the needs of target LEA students and their families. Student-level data, housed in the Vela Institute's Performance Insights (Pi) database, allows for rigorous evaluation that includes longitudinal analyses of student outcomes, identification and replication of effective instructional practices, and continuous improvement of service implementation to meet program objectives, evaluate the program, and conduct a quasi-experimental research study.

**AGREEMENT BETWEEN
WASHINGTON COUNTY SCHOOLS
AND
EAST TENNESSEE STATE UNIVERSITY**

This Agreement is by and between Washington County Schools, 405 W College Street, Jonesborough, TN 37659 (“COUNTY” or “Partner LEA”) and East Tennessee State University, 1276 Gilbreath Drive, Johnson City, TN, 37614 (“ETSU”), singularly “Party,” and together, “Parties.”

NOW, THEREFORE, in consideration of the covenants and conditions hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by each Party by affixing signature hereto, the Parties agree as follows:

- A. COUNTY agrees to perform the services outlined in the Statement of Work (Exhibit A) as part of ETSU’s grant from the U.S. Department of Education (“Prime Award”) for the ETSU GEAR UP project (“Project”), led by ETSU Principal Investigator Dr. Ronnie Gross.
- B. ETSU agrees to compensate COUNTY as follows for those services:
 - 1. The amount as outlined in the Budget (Exhibit B).
 - 2. Payments to COUNTY shall be made upon submittal of invoices by COUNTY and after performance of the portion of the services which the invoiced amount represents. The final payment shall be made only after COUNTY has completely performed its duties under this Agreement.
 - 3. COUNTY shall submit invoices no more frequently than monthly for the services provided.
 - 4. COUNTY shall include appropriate backup documentation with its invoices.
 - 5. ETSU shall, upon timely receipt of COUNTY’s invoice and backup documentation, reimburse COUNTY for such allowable amounts, within 30 days of receipt.
- C. COUNTY will submit reports to ETSU during the Project period as follows:
 - 1. Technical/progress reports and/or financial may be required by ETSU in order for ETSU to satisfy its reporting obligations on the Prime Award. In such instances, COUNTY shall submit a report to ETSU within 60 days of request by ETSU.
 - 2. Annual technical/progress reports shall be submitted within 60 days prior to the end of each budget period to Dr. Gross. Such report shall also note whether there are any changes to the upcoming budget period.
 - 3. A Final technical/progress report shall be submitted within 60 days of the end of the Project period or after termination of the award, whichever comes first, to Dr. Gross.
- D. The term of this agreement shall be from October 1, 2025, through September 30, 2032. The Parties may agree to extend the term by mutual written agreement.
- E. COUNTY certifies that it will perform its work on the Project in accordance with the terms and conditions of this Agreement and the applicable terms of the Prime Award, including the terms and conditions of the federal awarding agency.
- F. The Parties further agree that the following shall be essential terms and conditions of this Agreement.
 - 1. OFFICIAL SIGNATURE. Neither Party shall be bound by this Agreement until it is approved and signed by the appropriate official(s) indicated on the signature page of this Agreement.
 - 2. TERMINATION FOR CONVENIENCE. Either Party may terminate this Agreement by giving the other Party at least 30 days’ written notice before the effective termination date. COUNTY shall be entitled to receive equitable compensation for satisfactory authorized work completed and for non-cancellable obligations incurred as of the termination date.

3. TRAVEL. Unless otherwise indicated in the Agreement, if this Agreement provides for reimbursement for travel, meals, or lodging, such reimbursement must be made in accordance with the travel policies of COUNTY and ETSU.
4. RECORD KEEPING. COUNTY shall maintain documentation for all charges against ETSU under this Agreement. COUNTY's books, records and documents, insofar as they relate to work performed or money received under this Agreement, shall be maintained for a period of three full years from the date of final payment, and shall be subject to audit, at any reasonable time, upon reasonable notice, and at the expense of ETSU. These records shall be maintained in accordance with generally accepted accounting principles.
5. PUBLICATION. The Parties acknowledge that ETSU's policies and mission encourage the publication and / or other dissemination of information created pursuant to all of its work. Subject to the provisions of the other sections of this Agreement, the Parties acknowledge that nothing herein shall prohibit, limit, or interfere with ETSU's rights to publish or present the methods and results of the project.
6. CONDUCT. This Agreement is intended to support the sharing of research within the scientific community. ETSU, through the Principal Investigator, is solely responsible for the conduct, quality and scientific integrity of any research, and retains control over the conduct of any research, including, without limitation, the obligations to assure that the research has been conducted in accordance with all applicable laws, rules, and regulations.
7. INTELLECTUAL PROPERTY. The Parties acknowledge that all intellectual property developed by either Party prior to the Effective Date or outside of the scope of this Agreement is the property of said Party. The Parties acknowledge that during the course of the performance of this Agreement, intellectual property may be generated by COUNTY personnel alone or jointly with ETSU personnel. The following terms concerning intellectual property and inventions shall apply to this Agreement:

7.1 All rights and title to inventions and intellectual property, including, without limitation, copyrights, trademarks, patents, patent disclosures and inventions (whether patentable or not) developed in the course of this project shall be apportioned according to each Party's role in developing the same. All right and title to any final deliverables that are developed for or delivered to ETSU under this Agreement shall belong to ETSU.

7.2 ETSU hereby grants to COUNTY a non-exclusive, fully paid, royalty-free, world-wide license as to its interest in all intellectual property developed under this Agreement for non-commercial research, publication, dissemination, and teaching purposes by COUNTY.

8. CONFIDENTIALITY REVIEW. ETSU shall furnish copies of any proposed publication or other dissemination to COUNTY at least thirty 30 days in advance of the submission of such proposed publication or presentation. COUNTY shall have 30 days from the date on which notice is received to determine whether the proposed publication or other dissemination contains any of its Confidential Information. ETSU agrees, upon written request from COUNTY, to remove any such Confidential Information of COUNTY prior to publication or dissemination. ETSU shall otherwise have full control over all publication and / or dissemination materials.
9. CONFIDENTIAL INFORMATION. Confidential Information is information of a Party, which is disclosed in writing and clearly marked "Confidential" or "Proprietary", or if disclosed orally and identified as confidential at the time, is thereafter reduced to writing by the disclosing Party, clearly marked "Confidential" or "Proprietary" and transmitted to the receiving Party within 30 days after oral disclosure.

9.1 Confidential Information shall not include information that the receiving Party can demonstrate by documentary evidence (i) was, at the time of disclosure, in the public knowledge; (ii) became part of the public knowledge by publication or otherwise, except by breach of a duty by the receiving Party; (iii) was in the possession of the receiving Party at the time of disclosure; (iv) was received from an unrelated third

party, provided such information was not disclosed, to the receiving Party's knowledge, by said third party, directly or indirectly, in violation of any duty of confidentiality; or (v) that is independently developed by the receiving Party's employees or agents who are not privy to the disclosing Party's Confidential Information.

9.2 Nothing in this agreement shall prevent the Parties from disclosing any information, Confidential or otherwise, where they are required to do so by law, order of a Court, government agency, or otherwise pursuant to Tennessee's Public Records laws (T.C.A. Title 10, Chapter 7, as modified by § 49-7-120).

9.2.1 Either Party required to disclose the Confidential Information of the other Party shall notify the other Party, as soon as and to the extent practicable, in advance of any such disclosure of Confidential Information to enable the other Party to take, at the other Party's expense, any appropriate actions as the other Party sees fit under the circumstances, including but not limited to, for example, the seeking of a protective order.

10. ASSIGNMENT AND SUBAGREEMENT. Except as by operation of law, the Parties shall not assign this Agreement or enter into a sub-agreement for any of the services performed under this Agreement without obtaining the prior written approval of the other Party.
11. AUTHORITY. Each Party represents to the other that it has the right to enter into this Agreement without breaching or violating any fiduciary, contractual, or statutory obligations owed to another.
12. NOTICE. Unless otherwise specified in writing, any notice or submission required to be given to a Party under this Agreement shall be made in writing to the Party's authorized representative, indicated below, at the address provided above. Notice shall be effected by electronic mail, or by first class mail, postage prepaid, and return receipt requested, or by overnight courier capable of confirming delivery, and shall be deemed sufficiently given if and when received by the Party to be notified.
13. AMENDMENT. This Agreement may be modified, renewed or otherwise amended only by the written mutual consent of the Parties.
14. COMPLIANCE. The Parties shall comply with all applicable federal and state laws and regulations in the performance of this Agreement.
15. GOVERNING LAW. This Agreement shall be governed by the laws of the State of Tennessee.
16. INSURANCE. The State of Tennessee self-insures its exposures in general liability, automobile liability, professional malpractice and workers' compensation. The State's self-insurance program insures all liability created under Chapter 9, Title 8 of the T.C.A. for all State departments, agencies and institutions, including State institutions of higher education. The State of Tennessee prohibits ETSU from providing, carrying, or maintaining commercial general liability insurance or medical, professional or hospital liability insurance.
17. RESPONSIBILITY. Neither Party shall be responsible for personal injury or property damage or other loss except that resulting from its own negligence or the negligence of its employees or others for whom the Party is legally responsible.
18. CLAIMS. Any and all claims against the State, including ETSU or its employees, including any related to the performance of any responsibility specifically required under this Agreement or any contract, subcontract, or subaward, shall be submitted to the Tennessee Board of Claims or the Tennessee Claims Commission. Damages recoverable against ETSU shall be expressly limited to those claims paid by the Claims Commission pursuant to T.C.A. Section 9-8-301 et seq.
19. NON-DISCRIMINATION. The Parties agree that all policies, standards, and practices contained in the Agreement will be in full compliance with Title VI and VII of the Civil Rights Act of 1964 (P.L. 88-352),

Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Executive Order II, 246, The American Disabilities Act of 1990, and Part 80 of Title 40, Code of Federal Regulations, so that no person will be excluded from participation in, be denied benefits of, or otherwise be subjected to discrimination on the grounds of race, religion, creed, color, sex, gender, orientation, disability, veteran status, or national origin in the performance of this Agreement.

20. **USE OF NAME.** Neither Party shall use the other Party's name, trademarks, or other logos in any publicity, advertising, or news release without the prior written approval of an authorized representative of that Party. The Parties agree that either Party may use factual information regarding the existence and purpose of the relationship that is the subject of this Agreement for legitimate business purposes, to satisfy any reporting and funding obligations, or as required by applicable law or regulation without written permission from the other Party. In any such statement, the relationship of the Parties shall be accurately and appropriately described.
21. **ENTIRE AGREEMENT.** This Agreement embodies the entire understanding between the Parties and supersedes and replaces any and all prior understandings, arrangements, and/or agreements, whether written or oral relating to the Statement of Work. Further, the Parties agree that this Agreement shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and assigns.
22. **SEVERABILITY.** This Agreement is divisible and separable so that if any provision or provisions hereof shall be held to be invalid or if any provision hereof is held to be too broad to be enforced, such provision shall be construed to create an obligation to the full extent allowable by law, such that any such provision or provisions shall not impair the remaining provisions hereof, though only to the extent that such construction does not otherwise defeat the intents of the Parties.
23. **INDEPENDENT PARTIES.** The Parties hereto, in the performance of this Agreement, shall not act as employees, partners, joint venturers, or associates of one another. It is expressly acknowledged by the Parties hereto that such Parties are independent contracting entities and that nothing in this Agreement shall be construed to create an employer/employee relationship or to allow either to exercise control or direction over the manner or method by which the other transacts its business affairs or provides its usual services. The employees or agents of one Party shall not be deemed or construed to be the employees or agents of the other Party for any purpose whatsoever.
24. **WAIVER.** No waiver of any term, provision, or condition of this Agreement, whether by conduct or otherwise, in any one or more instances shall be or shall be construed as a further or continuing waiver of such term, provision, or condition.

EXHIBIT A – SCOPE OF WORK

Partner LEA will provide student and family programming, professional development, and an LEA Leader for this project. ETSU will reimburse Partner LEA for these activities as follows: (i) a base amount of \$12,000 to cover salary and benefits for 10% of the LEA Leader's time, and (ii) minimum of \$60,000 for student programming, which will be adjusted based upon student population. Specific activities and deliverables are outlined below.

1. Leadership
 - Appoint an LEA GEAR UP Leader (10% FTE) to serve as liaison between LEA and ETSU GEAR UP office.
 - Coordinate LEA-level activities and support implementation of GEAR UP services.
 - Participate on ETSU GEAR UP Advisory Board.
 - Assist with fiscal oversight and compliance for sub-award funds.
2. Annual Workplan Development
 - Develop and submit a comprehensive workplan for each target school by the established deadline.
 - Include services, timelines, and measurable objectives aligned with GEAR UP goals.
 - Engage stakeholders in review and feedback before final approval.
 - Update workplans annually based on evaluation data and program priorities.
3. Student and Family Programming
 - Implement activities funded by GEAR UP including college visits, career exploration, leadership programs, academic support, and FAFSA workshops.
 - Ensure programming aligns with the Think, Know, Act, Go framework.
4. Professional Development
 - Provide release time for faculty and staff to attend GEAR UP-sponsored professional development.
 - Collaborate with ETSU GEAR UP to schedule sessions focused on college-going culture and academic rigor.
5. Facilities and Resources
 - Provide office space for ETSU-hired Site Coordinators and access to necessary technology.
 - Make buses available for student travel to college visits and career events.
 - Support transition programs and other in-kind contributions.
6. Fiscal Accountability
 - Maintain financial oversight and compliance with federal and ETSU GEAR UP regulations.
 - Submit reimbursement requests with required documentation according to ETSU timelines.
 - Participate in annual fiscal audits and monitoring visits.
7. Advisory Board Participation
 - Ensure LEA representation at quarterly ETSU GEAR UP Advisory Board meetings.
 - Contribute to discussions on program implementation, evaluation, and sustainability.
8. Data and Evaluation
 - Provide timely student-level data for evaluation purposes.
 - Participate in surveys, focus groups, and other evaluation activities as requested.
 - Use evaluation feedback to improve services and update workplans.

9. Support for Reporting Requirements

- Support the annual reporting of GEAR UP activities and services that is required by the U.S. Department of Education by providing attendance rosters and sign-in sheets for all GEAR UP activities. ETSU GEAR UP tracks all activities provided to students, families, and professionals. For example, if a GEAR UP workshop occurs where participants gather at school in the evening, eat dinner, and discuss the college application process, a sign-in sheet would be needed to document and track the students served.

10. Graduate Tracking

- Provide a yearly list of high school graduates from GEAR UP schools, including First Name, Last Name, and Date of Birth. This will allow ETSU GEAR UP to begin tracking postsecondary enrollment in the coming years and assess whether GEAR UP increases college-going rates.

11. Compliance and Reporting

- Adhere to all federal, state, and ETSU GEAR UP policies, including FERPA and EDGAR requirements.
- Submit required reports and documentation by established deadlines.

12. Funding Formula

- Each LEA will receive \$12,000 for LEA Leader stipend and benefits.
- Minimum \$60,000 for student programming, adjusted by student population.
- Funds must be used exclusively for approved GEAR UP activities and cannot supplant existing programs.

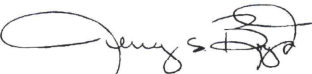

1. Description of Data:

Data will be shared in relation to the ETSU GEAR UP grant. Recipient is the prime awardee, and the grant has been awarded by the U.S. Department of Education.

The data points included in Exhibit A to this Data Transfer and Use Agreement will be transferred to Recipient and to third-party entity Vela Institute. Provider will provide data relating to students attending its schools. Provider will create export reports and will provide the data following this collection schedule: September, January, and June for each year of the grant program.

Provider will also share sign-in sheets for all GEAR UP activities as well as a yearly list of high school graduates from GEAR UP schools, including First Name, Last Name, and Date of Birth.

Provider will also collaborate with Recipient to administer surveys to students relating to pre-treatment college knowledge and pre-treatment FAFSA completions and college applications. These surveys will be administered through Qualtrics and will be shared for completion at least annually.

2. Description of Project:

The GEAR UP program provides financial and academic assistance and support, mentoring, and outreach to students with an aim to increase the number of low-income and first-generation students who are prepared to enroll and succeed in college. ETSU GEAR UP will serve 5,198 students in six low income Local Education Agencies (LEAs) across East TN during the seven-year grant period. Services will be provided to two cohorts of students. ETSU GEAR UP's project design is Think, Know, Act, Go: Educational Attainment and Economic Mobility. The design is grounded in the seminal college readiness work of David Conley. Adapting Conley's framework, four themes guide implementation and services: College-Going Culture (Think), Financial Literacy (Know), Academic Advising (Act), Postsecondary and Career Preparation (Go). ETSU GEAR UP provides required and permissible activities: tutoring, academic advising and counseling, dual-enrollment, college planning and financial aid workshops, mentoring, college visits, summer programming, non-cognitive skill development, financial literacy, college transition support to 7th year cohort students, and professional development to educators.

A collaborative evaluation approach with Vela Institute and ETSU research faculty will produce high quality evaluation. To meet project objectives, ETSU GEAR UP will use data to guide services, maximizing project effectiveness in meeting the needs of target LEA students and their families. Student-level data, housed in the Vela Institute's Performance Insights (Pi) database, allows for rigorous evaluation that includes longitudinal analyses of student outcomes, identification and replication of effective instructional practices, and continuous improvement of service implementation to meet program objectives, evaluate the program, and conduct a quasi-experimental research study.

General

Teleworking is a work arrangement where designated employees are allowed to perform their normal duties and responsibilities through the use of hardware and software at an alternate location from their normal work site.

The Director of Schools may require an employee to telework if the duties and responsibilities of the position are required during times of emergency. An employee's participation in the program will be determined by the length and duration of the emergency and will be both initiated and ended at the discretion of the supervisor and/or the Director of Schools. **Telework outside of times of emergency is not permitted.**

WORK ENVIRONMENT

Employees approved for telework shall maintain a dedicated and safe work environment.

An employee who teleworks shall not allow anyone other than district employees to utilize district provided services or equipment. Employees shall keep remote work and information confidential, in accordance with district policies, procedures, and applicable privacy laws.

The Board recognizes the value of proper nutrition, physical activity, and other health conscious practices and the impact that such practices have on student academic achievement, health, and well being. In order to provide an environment conducive to overall student wellness, this policy shall be followed by all schools in the district.¹

COMMITMENT TO COORDINATED SCHOOL HEALTH

All schools shall implement the CDC's Coordinated School Health approach to managing new and existing wellness related programs and services in schools and the surrounding community based on state law and State Board of Education CSH standards and guidelines. Washington County's Coordinated School Health Coordinator shall be responsible for overseeing compliance with State Board of Education CSH standards and guidelines in the school district.

SCHOOL HEALTH ADVISORY COUNCIL^{2,3}

A school district health advisory council shall be established to serve as a resource to school sites for implementing policies and programs and develop an active working relationship with the county health council. The council shall consist of individuals representing the school and community, including parents, students, teachers, school administrators, health professionals, school food service representatives, and members of the public. The primary responsibilities of the council include but are not limited to:

1. Developing, implementing, monitoring, reviewing, and as necessary, making recommendations as to physical activity and nutrition policies;
2. Ensuring all schools within the district create and implement an action plan related to all School Health Index modules;
3. Ensuring that the results of the action plan are annually reported to the council; and
4. Ensuring that school level results include measures of progress on each indicator of the School Health Index.

The State Board of Education's Coordinated School Health and Physical Activity policies shall be used as guidance by the council to make recommendations. The Board will consider recommendations of the council in making policy changes or revisions.

Additionally, each school will have a Healthy School Team consisting of but not limited to the school nurse, teachers, students, parents, community members, and administrators.² The Team will hold Healthy School Team meetings during the school year to assess needs and oversee planning and implementation of school health efforts. The Director of Schools/designee will ensure compliance with the school wellness policy, to include an assessment of the implementation of the wellness policy and the progress made in attaining the policy goals. The assessment will be made available to the public.

COMMITMENT TO NUTRITION

All schools within the district shall participate in the USDA child nutrition programs, which may include but not be limited to, the National School Lunch Program, the School Breakfast Program, the Summer Food Service Program, and the After School Snack Program.^{4,5,6}

Meals shall be accessible to all students in a non-stigmatizing manner. Students will be given adequate time to enjoy healthy meals and relax in a pleasant environment. Good nutritional habits shall be encouraged. All food including vending machines, fundraising items, and concessions must meet guidelines set forth by the Healthy, Hunger-free Kids Act, 2010, Smart Snacks in Schools.^{4,5,6} The school principal/designee shall be responsible for overseeing the school district's compliance with the State Board of Education rules and regulations for sale of food items in the school district.^{2,5,6}

Fundraising

Food-and beverages sold that can be consumed on campus during the school day must meet or exceed the USDA Smart Snacks guidelines in school nutrition standards. Schools shall follow the limit on days per semester in which non-healthy foods may be used for fundraisers.⁴

DISTRICT GOALS

The district will promote healthy nutrition through various activities, including nutrition related newsletters, informational links on the district website, healthy eating posters and bulletin boards in dining areas, and informational booths at various community functions. Nutrition education will be offered as part of a standards based program designed to provide students with the knowledge and skills needed to promote and protect their health as outlined in the State Board of Education Health Education and Lifetime Wellness Standards. Nutrition education will discourage teachers from using high fat, sugar, and sodium foods as rewards and encourage students to start each day with a healthy breakfast.

COMMITMENT TO PHYSICAL ACTIVITY AND PHYSICAL EDUCATION⁷

The Board recognizes that physical activity is extremely important to the overall health of a child. Schools shall support and promote physical activity. Physical activity may be integrated into any areas of the school program.

Unstructured physical activity periods shall be offered in addition to the school district's physical education program. Elementary school students shall receive a minimum of forty (40) minutes of physical activity each full school day. Middle and high school students shall receive a minimum of ninety (90) minutes of physical activity each full school week.

Physical education classes shall be offered as part of a standards based program designed to provide developmentally appropriate moderate to vigorous physical activity as an integral part of the class. All physical education classes shall comply with the State Board of Education's Physical Education Standards. In addition to the district's physical education program, non-structured physical activity periods shall be offered as required by law.

Schools shall continue to offer after school sports and activities. Physical activity shall not be employed as a form of discipline or punishment during scheduled curricular activities. This policy is not designed to address the use of physical activity as a form of discipline for students choosing to participate in extracurricular activities. The withholding of physical activity or physical education in response to inappropriate behavior such as failure to complete assignments or other negative behavior is not permitted. This does not refer to withholding physical activity, benching a student for a time period, because of inappropriate behavior during physical education class or other organized physical game/activity.

MARKETING OF SMART SNACKS

All food and beverage marketing within school premises, including vending machines, school stores, cafeteria displays, and promotional materials, must exclusively feature items that meet the USDA's Smart Snacks in School nutrition standards. Foods and beverages promoted through marketing materials must be in compliance with these standards, ensuring that only nutritious and healthy choices are encouraged. Food and beverage items that do not meet the Smart Snacks in School guidelines, such as sugary snacks, regular sodas, and high-calorie items, shall not be advertised or promoted through marketing initiatives within the school. Beverage vending machines located on school premises will exclusively offer beverages that meet Smart Snacks requirements. Non-compliant beverages, such as regular sodas and sugary drinks, shall not be available for purchase through school vending machines.

COMMITMENT TO CURRICULUM³

All applicable courses of study should be based on State-approved curriculum standards.

SCHOOL HEALTH INDEX³

All schools within the district shall annually administer a baseline assessment on each of the recommended School Health Index modules. Results shall be submitted to the School Health Advisory Council and reported to the State Department of Education.

RECORD KEEPING COMPLIANCE

The district's Coordinated School Health Coordinator shall ensure that records demonstrating compliance with community involvement requirements are maintained. The Coordinated School Health Coordinator shall additionally document that the school wellness policy and triennial assessments are made available to the public.⁸

The director of schools shall be the chief executive officer of the school system and shall have, under the direction of the board, general supervision of all the public schools, personnel, and departments of the school system. The director of schools is responsible for the management of the schools under the board's policies and is accountable to the board.¹ **The Director of Schools is the only employee directly employed by the Board of Education. All other employees of the district are employed, supervised, and managed under the authority of the Director of Schools.¹**

The Director of Schools is charged by the Board with the responsibility to oversee and manage all personnel matters within the district, consistent with applicable laws, regulations, and Board policies. This includes hiring, assignment, evaluation, discipline, and dismissal of employees, as well as the delegation of such duties as appropriate.²

Any teacher may enter into an agreement with parents for tutoring children for a fee, but this practice must be limited to those children who the teacher is not currently exercising teaching, administrative, or supervisory responsibility.¹ **No private teaching or tutoring shall be done during the hours of the regular school day.**

Any teacher who enters into a private tutoring agreement with a parent/guardian does so as an independent actor and not as an agent of the school district. The school district shall not be liable for any claims, damages, or liabilities arising from or related to private tutoring services provided by a school employee. The teacher providing such tutoring services shall assume full responsibility and liability, and agrees to indemnify and hold harmless the school district, its board members, administrators, and employees from any and all claims, demands, actions, or causes of action arising out of or in connection with such services.

School facilities may not be used for private profit.²

Employees have a right to express their views on any issue but must in each case make clear that the view expressed is not the official view of the board or school system.

Employees may, on their own time, campaign for or against any candidate or referendum but are prohibited from using system owned property to engage in political activity. District owned property includes, but is not limited to: all buildings, signage, message boards, telephonic equipment, electronic equipment, and email accounts. **District-owned property, including school buildings, district offices, and other facilities, shall not be used as a location for filming or recording content intended for political promotion or solicitation.** Employees shall not use audio or video messages to engage in any political promotion or solicitation during school hours.¹

REASONABLE SUSPICION DRUG TESTING

If a supervisor observes or receives a report of conduct suggesting a potential violation of Policy 1.804, Alcohol & Drugs in the Workplace, the supervisor shall promptly inform the Director/designee. Upon reasonable suspicion that an employee’s job performance or behavior may be impaired by illegal drugs, including improper use of prescribed drugs, or alcohol, the Director/designee may require the employee to undergo drug or alcohol testing.

An employee who is required to submit to drug or alcohol testing based upon reasonable suspicion and refuses shall be charged with insubordination, and necessary procedures will be taken to terminate the employee in accordance with board policy, and state law, where applicable.

An employee who tests positive on a reasonable suspicion test will be in violation of this policy and subject to termination.

The Director or his/her authorized designee are the only individuals in the district authorized to make the determination that reasonable suspicion or cause exists to order a drug screen and are the only individuals who may order an employee to submit to a drug screen.

Two types of cases for which reasonable suspicion procedures may be invoked are:

1. **Chronic Case:** Deteriorating job performance or changes in personal traits characteristics where the use of alcohol or drugs may be reasonably suspected as the cause.
2. **Acute Case:** Appearing in a specific incident or observation to then be under the present influence of alcohol or drugs, or investigation of an accident where the use of alcohol or drugs is reasonably suspected to be a contributing cause.

Circumstances under which substance screening may be considered, in either the chronic or acute cases, include, but are not limited to, the following:

1. Observed use, possession, or sale of illegal drugs and/or use, possession, sale, or abuse of alcohol and/or the illegal use or sale of prescription drugs.
2. Apparent physical state of impairment of motor functions.

3. Marked changes in personal behavior not attributable to other factors.
4. Employee involvement in or contribution to an accident where the use of alcohol or drugs is reasonably suspected or employee involvement in a pattern of repetitive accidents, whether or not they involve actual or potential injury.
5. Violations of criminal drug law statutes involving the use of illegal drugs, alcohol, or prescription drugs and/or violations of drug statutes.

The circumstances, under which substance screening may be considered, as outlined above, are strictly limited in time and place to employee conduct on duty or during work hours, or on or in Board of Education property, or at school system-approved or school-related functions.

Prior to substance screening, employees must sign an acknowledgment that the summary result will be transmitted to the Medical Review Officer and the Director/designee.

Drug and alcohol screening shall be conducted by Board approved, independent, certified laboratories utilizing recognized techniques and procedures. A breath analysis test will be performed by a certified Breath Alcohol Technician.

TESTING FOR CDL EMPLOYEES

All drivers and applicants for driver positions who are required to hold a Commercial Driver's License (CDL) to perform their job function shall adhere to the requirements of this policy and all procedures relating to this policy.¹

The use, possession, sale, purchase, or transfer of any controlled substances, except medically prescribed drugs on school property, while on school business, or while operating school vehicles and equipment, is prohibited. Drinking alcoholic beverages during working hours, four (4) hours before reporting to work, or having any measurable amount of alcohol in the employee's system during working hours is prohibited, whether on or off school property. Working hours include all breaks. Off-duty use of drugs and alcohol is prohibited to the extent that it affects the driver's attendance or performance and his/her ability to pass required Department of Transportation alcohol and controlled substance tests. Any violation of this policy is grounds for termination and possible legal prosecution.

The use of any prescription drug that could affect the central nervous system or one that would impair reaction time shall be reported to the Director of Schools/designee. Notice shall be given of non-prescription (over-the-counter) drugs being taken on a regular basis. The notice shall include the duration of ingestion and the possible side effects.

Procedures

The execution and enforcement of this policy will follow set procedures to screen bodily fluids, conduct breath testing, and/or search all employees/applicants for alcohol and drug use and those employees suspected of violating this policy who are involved in a reportable accident or who are periodically or randomly selected. The procedures are designed not only to detect violations of this policy but also to ensure fairness to each employee. Disciplinary action will be taken as necessary.

Implementation

The Director of Schools/designee is authorized to implement this policy and procedures for the drug testing program, including a periodic review of the program to address any problems, changes, and/or revisions of it, maintenance of all records required by the federal regulations, and determination upon board approval of how the program will be accomplished, whether in-house, contracted, or by consortium.

Dissemination

The Director of Schools/designee shall be responsible for communicating this policy and the procedures to all employees affected by this policy and shall be accountable for its consistent enforcement.² The Director of Schools/designee is designated to answer questions about this policy, procedures, and all other matters involved in alcohol and controlled substance testing of CDL drivers and the reasonable suspicion testing of all other employees. ~~It is the policy of the Washington County School System to maintain a workplace that is free from the effects of drug and alcohol abuse, subject to the following provisions:~~

- ~~1. It is prohibited for any employee to use or possess illegal controlled substances on or off duty;~~
- ~~2. It is prohibited for any employee to use legal drugs in a manner which might interfere with the employee's performance of duties;~~
- ~~3. Any employee found in violation of these provisions may be subject to disciplinary action;~~
- ~~4. Employees will be subject to testing for alcohol and controlled substances according to the procedures described in this policy.~~
- ~~5. Employees must notify their Department Head/Principal of any criminal drug statute conviction no later than the first work day following the conviction.~~

~~CLASSES OF EMPLOYEES~~

~~This policy applies to all employees and applicants of Washington County Schools. All employees are subject to pre-employment drug testing and reasonable suspicion drug and alcohol testing.~~

~~Commercial drivers license (CDL) holders, as part of their job duties, are also subject to additional drug testing requirements pursuant to a separate policy dictated the U.S. Department of Transportation. CDL holders are also subject to this policy.⁴~~

~~TESTS REQUIRED²~~

Pre-employment

~~All job applicants of Washington County Schools must consent to undergo drug testing at the time of the pre-employment/post-offer physical examination. Tests will be conducted after a provisional offer of employment has been made and before an employee performs a health or safety function for the first time.~~

Post-accident/Serious Incident

~~Alcohol and controlled substance tests will be conducted after accidents involving employees whose performance could have contributed to the accident, which results in (1) a fatality; (2) bodily injury which requires immediate medical treatment away from the scene of the accident, and/or; (3) in the case of a vehicle accident, damage requiring the vehicle to be towed away from the scene of the accident. Tests should be done as soon as practicable after the accident, although there should be no delay in any medical treatment required. Alcohol tests should be completed within two hours of the accident and in no event after eight hours and controlled substance tests will be administered within 32 hours of the accident.~~

~~Employees may be ordered to test any time they use force, which is reasonably calculated to produce death or serious bodily injury. Serious bodily injury is any injury that creates a substantial risk of death; causes permanent disfigurement or results in long-term loss or impairment of any bodily member or organ.~~

Reasonable Suspicion

~~When a supervisor observes and documents appearance, behavior, speech, or body odors of an employee, which are characteristic of the use of alcohol or controlled substances, drug and alcohol tests may be ordered. Observations may include symptoms of chronic use or withdrawal. Supervisors must document these observations on the approved form. The Director of Human Resources or his/her designee will review the documentation and pertinent information ascertains the suspicion. If the Director of Human Resources or his/her designee agrees, he/she will order the employee to submit to a controlled substances and/or alcohol test.~~

~~No employee shall be allowed to drive or perform any health or safety function when suspected of being impaired, until a test report that the employee is medically qualified to work is received.~~

HOW TESTS WILL BE DONE²

Alcohol

~~Alcohol is defined as any food, beverage, mixture or preparation, including any medication, containing ethyl alcohol. Testing for the use of alcohol will be done using evidential breath testing (EBT) devices approved by the federal government. EBT devices determine the concentration of alcohol in the blood alcohol concentration (BAC). If the BAC is less than four-hundredths of one percent (.04%) by weight of alcohol in the blood, the test is considered negative. This is the standard for all employees although a CDL holder is not allowed to drive with a BAC greater than two-hundredths of one percent (.02%). If the BAC is four-hundredths of one percent (.04%) or greater, the test is considered positive and a second test will be conducted immediately after the initial test to confirm the result of the initial test. Washington County Schools reserves the right to order a blood test as additional confirmation in extraordinary situations.~~

Controlled Substances

~~Controlled substance tests will be done by urinalysis and will check for the following drugs:~~

- ~~Acetylmorphine~~
- ~~Amphetamines~~
- ~~MDA~~
- ~~Cocaine~~
- ~~Marijuana (THC metabolite)~~
- ~~Opiates (including heroin and codeine)~~
- ~~Opiates-Semi-Synthetic~~
- ~~Oxycodones~~
- ~~Phencyclidine (PCP)~~

~~Tests may be requested for other substances if there is reason to believe that a test for the substances may be positive. Analysis shall be conducted by a laboratory certified by the U.S. Department of Health and Human Services (DHHS). If a screening test is positive for a controlled substance, a confirmation test is performed using the gas chromatography/mass spectrometry (GC/MS) analysis. The urine sample will be split in case of the possibility of retest. Levels constituting a positive test are established by DHHS. A positive test is considered the same as being under the influence of drugs for the purpose of this policy.~~

~~NOTIFICATION OF RESULTS AND ROLE OF THE MRO~~

~~All controlled substances tests are reviewed and interpreted by a physician designated as the Medical Review Officer (MRO) before they are reported to the employer. If the laboratory reports a confirmed positive result to the MRO, the MRO contacts the employee or applicant to determine if there is an alternative medical explanation for the substances found in the urine specimen.~~

~~If the employee provides appropriate documentation and the MRO determines that it is legitimate medical use of the prohibited substances, the result is reported as negative to the employer although the employee may not be medically qualified to perform normal functions. The Director of Human Resources (or designee) will notify the employee of test results, and if positive, will inform the employee to contact the MRO if the MRO has been unable to contact the employee.~~

~~CONSEQUENCES OF A POSITIVE TEST~~

~~*Refusal to Test*~~

~~Any refusal to submit to a test shall be considered a positive test. Willful refusal to test, or an attempt to tamper with the test, is in violation of this policy and will be considered a positive test. Refusal to submit may include failure to provide an adequate breath or urine sample for testing unless medical reasons are confirmed.~~

~~An employee who tests positive or who refuses to test will be subject to disciplinary action up to and including termination.~~

~~*Removal from Normal Duties*~~

Removal from Eligibility

~~Employees and applicants who have a confirmed positive pre-employment test result for controlled substances or alcohol or refuse to test will be denied employment and may be considered ineligible for future employment~~

~~Employees who have a confirmed positive result on any test for controlled substances or alcohol shall be subject to further action, which may include rehabilitation and/or disciplinary action up to and including termination. Disciplinary action is at the discretion of the Director of Schools. The Director of Schools may take into account factors such as the circumstances which led to testing, the employee's work history, length of employment, job performance, and past corrective or disciplinary action.~~

~~*Disciplinary action, based on a violation of this substance abuse policy, is not automatically suspended by an employee's participation in an Employee Assistance Program and disciplinary action may be imposed upon the employee if the Director of Schools finds such action warranted*~~

~~RE-TEST PROVISION~~

~~Breath alcohol tests are conducted and confirmed while the employee or applicant is present, eliminating the need for a re-test. For controlled substances, an employee or applicant who has confirmed positive test results may request that the split sample be tested at a separate laboratory with federal certification. Such request must be made within seventy-two (72) hours of learning of the confirmed positive test. Any action required by this policy as the result of a positive test is not stayed pending the result of a test on a split sample. All costs associated with the re-testing of the split sample must be prepaid by the employee, including shipping and handling, transportation, testing and MRO assessment. If the result of the retest is negative, these costs will be reimbursed to the employee.~~

~~RETURN TO WORK AND FOLLOW-UP~~

~~Employees with a confirmed positive test for controlled substances or alcohol may be referred to the Employee Assistance Program in addition to or in lieu of disciplinary action. Employees shall not be allowed to return to normal duties until they submit to a return to work test with confirmed negative results and are recommended by the Employee Assistance or other appropriate counselor to return.~~

~~Employees with a confirmed positive test who are allowed to return to work shall be required to sign a Return to Work Agreement prior to returning to work. For follow-up alcohol tests, any level will constitute a positive, even if it is below the normal cut-off level of a BAC of four-hundredths of one percent (.04%). Failure to comply with the Return to Work Agreement will subject an employee to disciplinary action.~~

~~OPERATING WASHINGTON COUNTY SCHOOL SYSTEM EQUIPMENT~~

~~No employee shall be allowed to operate a school system vehicle following a positive test for a minimum period of ninety (90) calendar days after presenting a negative return-to-work test. The same requirement shall apply to an employee whose license is suspended due to a DUI conviction, even if the employee is granted a restricted license. A Return-to-Work Agreement is also required in such cases. If driving is an essential function of the position, the employee may be demoted until all restrictions are lifted.~~

~~CONFIDENTIALITY~~

~~Washington County Schools, the company contracting to administer the testing program, the testing laboratory, and the Medical Review Officer shall strictly maintain the confidentiality of controlled substances and alcohol testing results and records. These results cannot be released to others without the written consent of the employee. Exceptions to these confidentiality provisions are limited to the decision-maker in litigation or administrative proceedings or officials designated in the federal regulations. Statistical records are maintained for required reports.~~

~~Employees involved in testing and the administration of this policy shall observe strict confidentiality of an employee's test results and treatment. Any employee who violates this requirement for confidentiality will be subject to disciplinary action.~~

~~TRAINING³~~

~~Informational Program - All employees will be made aware of this policy. The policy will be made known to all new employees and the information will be incorporated in new employee orientation.~~

~~Supervisors - Supervisors shall attend a program of training. This program will be designed to teach supervisors how to identify and document substance abuse among employees and to familiarize them with the controlled substances testing program, provisions of this policy, and related laws.~~

~~Program Administrator - the Director of Human Resources serves as the liaison with the company who manages testing and reporting~~

~~CONFLICT WITH OTHER LAWS OR COURT ACTION~~

~~If any provision of this policy or the application thereof, to any person or circumstance is held to be invalid, the invalidation shall not affect any other provisions or the application of this program and to this end the provisions of the program are declared to be severable.~~

~~ADMINISTRATIVE PROCEDURES~~

~~The Director of Schools shall develop administrative procedures in accordance with the *Tennessee Drug Free Workplace Employer's Program Development and Implementation Guide (October 1997)* and state law and regulations.~~

An employee who has a communicable disease shall not perform his/her duties in any location where such might endanger the health of students. ~~No employee who has any communicable disease shall perform his/her duties in any location where such might endanger the health of school children.~~ The ~~board~~ Board shall require any employee to submit to a physical examination by a physician whenever there is reason to believe that the employee has any communicable disease.²

The Director of Schools shall reassign an employee to alternate duties, place employee on administrative leave with pay, or temporarily remove employee from the school setting who is suspected of having a communicable disease which might endanger the health of students, pending investigation and final disposition of the case before the Board.

To assist the Board in making final disposition of the case, the Director of Schools may refer the case to the County Health Office or other medical experts.

~~The director of schools shall reassign or suspend any employee who is suspected of having a communicable disease which might endanger the health of children, pending investigation and final disposition.~~

~~In the event an employee has been exposed to a communicable disease but is asymptomatic and has not tested positive for the disease, and pursuant to guidance from the Tennessee Department of Health or the local health department, the Washington County Board of Education delegates to the director of schools the discretion to permit the employee to continue working provided that each of the following criteria are met:~~

- ~~● The director determines that the employee performs an essential function in support of critical infrastructure, as those terms are used by state and federal agencies, and that the employee cannot perform those essential functions remotely;~~
- ~~● The employee remains asymptomatic and has not tested positive;~~
- ~~● The employee wears all necessary and appropriate protective equipment, such as, but not limited to, face masks, while on school campus;~~

PROFESSIONAL PERSONNEL

Professional personnel shall earn one (1) day of sick leave for each month employed during the school year, and these days shall accumulate for an unlimited number of days.¹

~~A teacher shall be allowed to use unearned sick leave up to the amount of days which such teacher may accumulate during the remainder of the school year in which they are employed. Such advance use of sick leave shall be charged to sick leave accumulated in the same school year. Upon termination of the employment of such teacher before such days are earned or at the end of the school year, there shall be deducted from the final salary of such teacher an amount based on their daily rate of pay sufficient to cover the excess sick leave days used by him. If such final salary is insufficient for this purpose, the teacher shall be liable for reimbursement of any amount in excess of their final salary.~~

Sick leave shall be defined as: illness of a teacher from natural causes or accident, quarantine, or illness or death of a member of the immediate family of a teacher, including the teacher's wife or husband, parents, grandparents, children, grandchildren, brothers, sisters, mother-in-law, father-in-law, daughter-in-law, son-in-law, brother-in-law, and sister-in-law.²

A signed statement listing the cause of absence shall be provided by the employee on forms furnished by the Director of Schools and shall promptly be given to the immediate supervisor in support of all claims for sick leave pay. A falsified statement shall be grounds for dismissal. **An employee absent for five (5) consecutive working days shall submit a doctor's statement verifying illness or injury of the employee or immediate family member.**

Frequent use and/or suspected misuse of sick leave by an employee are sufficient grounds for requiring a physician's certificate stating the reason for absence.

Documentation from a physician may be required in support of any claim for sick leave pay.

~~A certificate from the physician on forms furnished by the Board may be required in support of any claim for sick leave pay.³ If there is any reason to doubt the validity of the certification provided, the director of schools may require, at the expense of the Board, an opinion of a second physician.~~

The principal shall notify the Director of Schools' office at once if an employee is sick beyond ~~twenty (20) consecutive instructional days~~ **the limit of his/her sick leave accumulation.** ~~The substitute teacher, at this point, must have a certificate or permit and must be paid according to the state salary scale.~~

Permanent, cumulative sick leave records for each active professional employee shall be kept in the Director of Schools' office.

A teacher, upon employment, may transfer his/her accumulated sick leave from another Tennessee school **system district**, provided that the Director of Schools of the system in which the accumulated leave was held provides notarized verification.³

SUPPORT PERSONNEL

Support personnel shall earn one (1) day of sick leave for each month an employee is employed. Sick leave may not be earned during the employee's initial three (3) month employment which shall serve as a probation period.

At the termination of the employment of any employee, all unused sick leave accumulated by the employee shall be forfeited for purposes of pay but may be used toward retirement under applicable law.

The immediate supervisor may require ~~a physician's certificate~~ **documentation from a physician** stating the reason for absence.

SICK LEAVE BANK (if applicable)

The purpose of the sick leave bank is to provide sick leave to all employees⁴ who have suffered an unplanned personal illness, injury, disability, or quarantine and whose personal sick leave is exhausted.

To form a sick leave bank, a minimum of twenty (20) employees from the school **system district** shall petition the Board for permission to establish a sick leave bank.⁵ Upon approval, sick leave bank trustees shall be appointed and shall operate as the governing body of the sick leave bank and shall enact rules and regulations consistent with state law.⁶ Employees wishing to participate shall initially give a maximum of three (3) days of sick leave. These days are to be deducted from the employee's personal accumulation and donated to the sick leave bank. Donations of sick leave to the bank are nonrefundable and nontransferable.⁷

At any time the number of days in the sick leave bank is less than twenty (20), or one (1) per employee if there are more than twenty (20) members, or at any time deemed advisable, the trustees shall assess each member one (1) or more days of accumulated sick leave. If an employee has no accumulated sick leave at the time of assessment, the first earned days shall be donated as they are accrued by the employee.⁷

An employee who is a member of the sick leave bank may request an allotment of days (for the employee's personal illness or on account of an illness of his/her minor child) in the manner designated by the trustees. The need for these days shall be verified by a statement from a doctor.⁸

By written notice to the trustees, an employee may withdraw from bank participation on June 30th of any year.⁹ Membership withdrawal results in forfeiture of all days contributed.

The sick leave bank shall be operated in accordance with state law.¹⁰

~~MEDICAL INSURANCE WHILE ON UNPAID LEAVE~~

~~If an employee is ineligible for FMLA and has exhausted all accumulated sick leave, the Board portion of medical insurance will be paid for an employee on unpaid leave for a maximum of 90 days. The employee portion must be paid directly to Washington County Schools if the employee is not receiving a paycheck sufficient to cover the premium amount due. If the employee portion is not received by the 30th of each month, insurance will be terminated. After ninety (90) days, the employee will be responsible for the full premium amount, to be paid directly to the state by the employee.~~

If an investigation of an employee's conduct is required, the Director of Schools shall determine whether to temporarily modify the employee's work status based on concerns for safety or to minimize disruption to the educational environment. This may include, but is not limited to:

- Reassignment to alternate duties;
- Placement on administrative leave with pay; or
- Temporary removal from the school setting.

Such action shall not be considered disciplinary in nature but rather a precautionary measure until a determination can be made regarding an appropriate return to duties, or the imposition of disciplinary action, which could include suspension without pay.

SUSPENSION

A Director of Schools/designee ~~director of schools or his/her designee~~ may suspend an employee at any time when deemed necessary.¹

Under no circumstances shall a Director of Schools ~~director of schools~~ suspend an employee with pay if a Department of Children's services or criminal investigation is pending. If reinstated, the employee shall be paid full salary for the period of suspension, unless suspension without pay is deemed to be an appropriate penalty.

DISMISSAL

All non-certified (classified) employees are employed at the will of the Director of Schools ~~director~~. The Director of Schools ~~director of schools~~ may dismiss any non-certified employee during the year for any lawful reason.

RESIGNATION

Support personnel shall give the immediate supervisor written notice of resignation ~~at least two (2) weeks (ten (10) working days)~~ ten (10) working days in advance of the effective date of voluntary

termination. The ten (10) working days may be waived by the Director of Schools ~~director of schools~~ for justifiable reason.

The immediate supervisor shall forward copies the day received to the Director of Schools' ~~director of schools'~~ office. The payroll office will prepare final payment for the next appropriate scheduled pay day.

RETIREMENT

Retirement shall mean a termination of services under conditions which will allow the employee to draw benefits from retirement plans and/or social security benefits. Employees eligible for retirement benefits may elect to retire at any age according to the provisions of the retirement system.

Central office personnel shall assist employees in securing retirement benefits; however, it shall be the responsibility of the retiring employee to obtain verification of eligibility in writing from the Tennessee Consolidated Retirement System (TCRS) ~~TCRS~~ to the central office. It shall be the responsibility of the retiring employee to file for eligible benefits. Employees who retire under TCRS may be employed up to one hundred twenty (120) days per year without loss of retirement benefits.²

ALLEGATIONS REQUIRING TEMPORARY REMOVAL FROM DUTY

If an investigation of an employee’s conduct is required, the Director of Schools shall determine whether to temporarily modify the employee’s work status based on concerns for safety or to minimize disruption to the educational environment. This may include, but is not limited to:

- Reassignment to alternate duties;
- Placement on administrative leave with pay; or
- Temporary removal from the school setting.

Such action shall not be considered disciplinary in nature but rather a precautionary measure until a determination can be made regarding an appropriate return to duties, or the imposition of disciplinary action, which could include suspension without pay.

SUSPENSION PENDING AN INVESTIGATION¹

The Director of Schools may suspend a teacher at any time that may seem necessary, pending investigation, or final disposition of a case before the Board or an appeal. If the matter under investigation is not the subject of an ongoing criminal investigation or a Department of Children's Services investigation, and if no charges for dismissal have been made, a suspension pending investigation shall not exceed ninety (90) days in duration. Under no circumstances shall the Director of Schools suspend a non-tenured teacher with pay **if there is a pending investigation**. If vindicated or reinstated, the non-tenured teacher shall be paid full salary for the period of suspension.

SUSPENSION OF THREE DAYS OR LESS²

The Director of Schools/designee may suspend a teacher for incompetence, inefficiency, neglect of duty, unprofessional conduct, and insubordination. Before a teacher is suspended, he/she shall be: (1) provided with written notice, including the reasons for the suspension along with an explanation of the evidence; (2) given an opportunity to respond to the Director of Schools at a recorded conference, if requested within five (5) days; and (3) given a written decision of the suspension within ten (10) days. Both parties may be represented by counsel at the conference, which shall be recorded.

Under no circumstances shall the Director of Schools suspend a non-tenured teacher with pay. If reinstated, the non-tenured teacher shall be paid full salary for the period of suspension unless suspension without pay is deemed to be an appropriate penalty.

DISMISSAL OR SUSPENSION GREATER THAN THREE DAYS²

The Director of Schools may dismiss or suspend for more than three (3) days any non-tenured teacher during the contract year for incompetence, inefficiency, insubordination, improper conduct, or neglect of duty after giving the non-tenured teacher, in writing, due notice of the charges.

The Director of Schools shall give the non-tenured teacher an opportunity for a full and complete hearing before an impartial hearing officer.

The Board will appoint an impartial hearing officer to conduct such hearings. The hearing officer will hear the case, and the teacher shall have the right to:

1. Be represented by counsel;
2. Call and subpoena witnesses;
3. Examine all witnesses; and
4. Require that all testimony be given under oath.

Factual findings and decisions in all dismissal cases shall be reduced to written form and delivered to the affected teacher within ten (10) working days following the close of the hearing. The teacher may appeal the decision to the Board within ten (10) working days of the hearing officer rendering the written decision to the teacher. Written notice of appeal to the Board shall be given to the Director of Schools. Within twenty (20) working days of receipt of notice, the Director of Schools shall prepare a copy of the proceedings, including all transcripts and evidence, documentary or otherwise, and provide a copy to the Board.

The Director of Schools shall also have the right to appeal any adverse ruling by the hearing officer in the same manner as the non-tenured teacher.

The Board shall hear the appeal. No new evidence shall be introduced. The non-tenured teacher may appear in person or be represented by counsel and argue why the decision should be modified or reversed. The Board shall take one of the following actions:

1. Sustain the decision;
2. Send the record back if additional evidence is necessary; or
3. Revise the penalty or reverse the decision.

Before any decision to dismiss is made, a majority of the membership of the Board shall concur in sustaining the charges. The Board shall render a decision on the appeal within ten (10) working days after the conclusion of the hearing.

Within twenty (20) working days after receipt of notice of the decision of the Board, either party may appeal to the chancery court in the county where the school district is located. The Board shall provide the entire record of the hearing to the court.

NONRENEWAL

Non-tenured teachers are subject to the same rules and regulations and are entitled to the privileges of employment enjoyed by tenured teachers except that they have no claim upon continuing employment or tenure protections.

The principal is responsible for discussing deficiencies as part of the evaluation process with the non-tenured teacher and providing assistance for overcoming these deficiencies.

The Director of Schools is under no obligation to re-employ non-tenured teachers at the end of their contract period. If the Director of Schools determines not to renew the contract of a non-tenured teacher, the following action shall be taken:

1. The Board shall be notified at the next regular board meeting; and
2. Written notice of non-renewal shall be sent to the teacher by certified mail, overnight carrier, or by email within five (5) business days following the last instructional day for the school year.³ If the reason for nonrenewal is due only to a loss of funding for the position, then the notice shall include a statement listing it as the cause for nonrenewal.⁴

RESIGNATION

A teacher shall give the Director of Schools notice of resignation at least thirty (30) days before the effective date of the resignation.⁵ The Board may waive the thirty (30) days notice requirement and permit a teacher to resign in good standing.

The conditions under which it is permissible to break a contract with the Board are as follows:⁶

1. The incapacity on the part of the teacher to perform the contract as evidenced by the certified statement of a physician approved by the Board; or
2. The release by the Board of the teacher from the contract which the teacher has entered into with the Board.

Any teacher on leave shall notify the Director of Schools in writing at least thirty (30) days prior to the date of return if the teacher does not intend to return to the position from which he/she has taken leave. Failure to render such notice may be considered a breach of contract.⁷

Upon a breach of contract, the Board, upon a motion recorded in its minutes, may file a complaint with the State Board of Education and request the suspension of a teacher's license. After the State Board of Education has provided the teacher an opportunity for defense during a hearing, the State Board of Education may suspend the license for no less than thirty (30) days and no more than three hundred sixty-five (365) days.⁸

RETIREMENT

Retirement is a termination of services under conditions which will allow the teacher to draw benefits from retirement plans and/or Social Security benefits.

Teachers eligible for retirement benefits may elect to retire at any age according to the provisions of the retirement system. Central office personnel shall assist teachers in securing retirement benefits; however, it shall be the responsibility of the retiring teacher to provide verification of eligibility in writing from the Tennessee Consolidated Retirement System (TCRS) to the central office. It shall be the responsibility of the retiring teacher to file for benefits.

(Note: Nonrenewal of non-tenured teachers after the contract year is not suspension or dismissal and does NOT follow the suspension/dismissal guidelines outlined in this policy. Rather, nonrenewal of non-tenured teachers after the contract year follows the nonrenewal guidelines outlined in this policy.)

Under no circumstances shall a Director of Schools suspend a tenured teacher with pay. If reinstated, the tenured teacher shall be paid full salary for the period of suspension unless suspension without pay is deemed to be an appropriate penalty.

DISMISSAL OR SUSPENSION GREATER THAN THREE DAYS⁴

No teacher shall be dismissed or suspended except as provided in this part.

The causes for which a teacher may be dismissed or suspended are: incompetence, inefficiency, neglect of duty, unprofessional conduct, and insubordination, as defined in 49-5-501.

A director of schools may suspend a teacher at any time that may seem necessary, pending investigation or final disposition of a case before the board or an appeal. If the matter under investigation is not the subject of an ongoing criminal investigation or a department of children's services investigation, and if no charges have been made pursuant to subdivision (a)(4), a suspension pending investigation shall not exceed ninety (90) days in duration. If vindicated or reinstated, the teacher shall be paid the full salary for the period during which the teacher was suspended.

When a tenured teacher is charged with offenses that may justify dismissal or a suspension greater than three (3) days, the charges shall be made in writing, specifically stating the offenses that are charged, and shall be signed by the party or parties making the charges.

If, in the opinion of the Board, the charges are of such nature as to warrant the dismissal or a suspension greater than three (3) days of the teacher, the Director of Schools shall give the teacher a written notice of this decision, a copy of the charges against the teacher, and a copy of a form provided by the Commissioner of Education advising the teacher of his/her legal duties, rights, and recourse.

A tenured teacher who has been given notice of charges against him/her may within thirty (30) days after receipt of notice give written notice to the Director of Schools of his/her request for a hearing.

The Director of Schools shall, within five (5) days after receipt of request, assign a hearing officer from the list maintained by the Board.

The Board shall maintain a list of qualified individuals who have indicated a willingness to act as impartial hearing officers as defined under Tennessee law.

The hearing officer shall notify the parties, or their attorney, of the officer's assignment and direct the parties or the attorneys for the parties, or both, to appear before the hearing officer for simplification of issues and the scheduling of the hearing. That hearing shall be set no later than thirty (30) days following receipt of the initial request for a hearing. In the discretion of the hearing officer, all or part of any prehearing conference may be conducted by telephone if each participant has an opportunity to participate, be heard, and to address proof and evidentiary concerns. The hearing officer is empowered to issue appropriate orders and to regulate the conduct of the proceedings.

Either party may appeal to the Board an adverse ruling by giving written notice of appeal within ten (10) working days of the hearing officer's delivery of the hearing officer's written findings and conclusions. The Director of Schools shall prepare a copy of the proceedings, including all transcripts

and evidence, documentary or otherwise, and transmit the same to the Board within twenty (20) working days of the receipt of the notice of appeal.

The Board shall hear the appeal on the record, and no new evidence may be submitted by either party. The appealing party may appear before the Board to argue why the adverse ruling should be overturned. In no event should such argument last more than fifteen (15) minutes unless the Board votes to extend additional time. At the conclusion of the hearing, any member of the Board may vote to sustain the decision of the hearing officer, send the record back for additional evidence, revise the penalty, or reverse the decision. The Board shall render its decision within ten (10) working days after the conclusion of the hearing. In the event that the decision of the Board is appealed to the chancery court, the Board shall transmit the entire record prepared by the Director of Schools and reviewed by the Board to the chancery court for its review.

RESIGNATION

A teacher shall give the Director of Schools notice of resignation at least thirty (30) days before the effective date of the resignation. A teacher who fails to give such notice, in the absence of justifiable extenuating circumstances, shall forfeit all tenure status. The Board may waive the thirty (30) days' notice requirement and permit a teacher to resign in good standing.⁵

The conditions under which it is permissible to break a contract with the Board are as follows:⁶

1. The incapacity on the part of the teacher to perform the contract as evidenced by the certified statement of a physician approved by the Board; or
2. The release by the Board of the teacher from the contract that the teacher has entered into with the Board.

Any teacher on leave shall notify the Director of Schools in writing at least thirty (30) days prior to the date of return if the teacher does not intend to return to the position from which he/she has taken leave. Failure to render such notice may be considered a breach of contract.⁷

Upon a breach of contract, the Board, upon a motion recorded in its minutes, may file a complaint with the State Board of Education and request the suspension of a teacher's license. After the State Board of Education has provided the teacher an opportunity for defense during a hearing, the State Board of Education may suspend the license for no less than thirty (30) days and no more than three hundred sixty-five (365) days.⁸

RETIREMENT

Retirement is a termination of services under conditions that will allow the teacher to draw benefits from retirement plans and/or Social Security benefits. Teachers eligible for retirement benefits may elect to retire at any age according to the provisions of the retirement system.

Central office personnel shall assist teachers in securing retirement benefits; however, it shall be the responsibility of the retiring teacher to provide verification of eligibility in writing from the Tennessee Consolidated Retirement System (TCRS) to the central office. It shall be the responsibility of the retiring teacher to file for benefits.

The ~~director of schools or his/her designee(s)~~ **Director of Schools/designee(s)** shall be authorized to maintain personnel records and to permit inspection of the same, except for matters deemed confidential by law. The following personnel records shall be maintained for all employees as appropriate:

1. Employee applications and contracts;
2. Professional certificates and other documents required by state and federal laws and regulations;¹
3. Evaluations;
4. Cumulative information files; and
5. **INS Form I-9²; and**
6. **Disciplinary action, as appropriate and any response from the employee.**

The following guidelines shall be followed:

1. Information contained in personnel records shall be limited to job-related matters;
2. The ~~director of schools~~ **Director of Schools** shall be responsible for notifying all employees of the types of records kept and uses made of such records;
3. Employees shall be granted an opportunity to respond in writing to material placed in records;
4. Employee records are public records, except for matters deemed confidential by law, and shall be open for inspection during regular business hours;³
5. In accordance with federal law, the district shall release information regarding the professional qualifications and degrees of teachers and the qualifications of paraprofessionals to ~~parents~~ **parent(s)/guardian(s)** upon request for any teacher or paraprofessional who is employed by a school receiving Title I funds and who provides instruction to their child at that school;⁴
6. Members of the public may not obtain the home telephone number, personal cell phone number, bank account information, social security number, residential street address, driver license information (except where driving or operating a vehicle is considered to be a part of the employee's duties), or the results of individual teacher evaluations of an employee or of the immediate family members or household members of an employee, unless release of this

information is expressly authorized by the employee;⁵

7. A record of the person inspecting and the date of inspection shall be recorded and notification given to the employee; and
8. Copies of records may be made under rules determined by the **Director of Schools** ~~director of schools~~.⁶

The board encourages field trips and excursions when the experiences are an integral part of the school curriculum and contribute to the board's desired educational goals.

The director of schools shall develop forms and procedures for submitting, reviewing, and approving requests for field trips. **Any request for a field trip, excursion, or competition which requires students to travel out of state or stay overnight requires prior board approval.**

The following guidelines shall be followed in planning and conducting field trips and excursions:

1. Any teacher or principal desiring to take a group of students away from the school on an education field trip requiring transportation must obtain advanced approval of the director. Field trips in the immediate vicinity of the school and not requiring transportation may be approved by the principal;
2. The trip must have a definite purpose and reflect careful planning. Students should be prepared by general class discussion and/or research;
3. If bus transportation is required, the principal or their designee shall make the necessary arrangements. A fee will be charged to the school for mileage when school system buses are used;
4. Signed parental permission forms must be obtained for every student make an off-campus trip beyond the immediate vicinity of the school. The principal shall ensure that these forms are kept on file for the remainder of the school year. The form for parental permission must include: purpose, date, time of departure & return, travel plans, destination, number of chaperons, personal expense involved, rules of conduct and penalties for violation, and other facts necessary for parents to be fully informed. This information is to be completed by the school before the form is signed by the parents;
5. Overnight educational trips and chaperones must be approved by the director of schools in advance. These groups must be accompanied by at least one regular staff member and others from the school who are appropriate for adequate supervision and shall be responsible for student conduct while away. There must be at least one female and one male chaperon if the trip is for a mixed group;
6. Students shall not be penalized for participating in approved school-sponsored trips and activities. Teachers shall permit students to make up class assignments missed because of a trip or activity;
7. All accidents that occur on a school-sponsored trip must be reported by the teacher to the principal immediately upon returning to school. Serious accidents involving personal injury must be reported to the principal and/or director of schools. An emergency shall be dealt with promptly by the teacher or other members of the school staff by taking appropriate action,

including sending the student to the hospital or summoning medical aid or ambulance. In cases where it is necessary to send the student to the hospital, reasonable effort must be made to notify the parents;

8. Any school-sponsored trip not meeting the “educationally beneficial” criteria as defined in this section must have prior approval of the director of schools or their designee.
9. Any school-sponsored trip which is out of country, both out-of-state and overnight must have prior approval by the Board; and
10. Students who are members of the above group who do not go on the field trip are required to attend regular classes.

Any trip for which a fee is charged as defined by state board policy is prohibited.¹

INDEPENDENTLY PLANNED TRIPS

Trips privately planned by school district employees, acting outside the scope of their employment, are not authorized by the school district.

These trips are not approved by the Board and are not considered a part of the curriculum. Total responsibility for privately planned trips rests with the chaperone(s) as well as with the parent(s)/guardian(s) of the students participating in the trip. The following restrictions shall apply:

1. Board funds or resources shall not be used;
2. School district materials shall not be used;
3. The Board shall not assume any liability;
4. Employees are not authorized to act on behalf of the school district;
5. Recruitment efforts made by an employee shall not occur during the instructional school day;
6. Employees are not authorized to recruit students in any privately planned trip except to the extent that the school also permits third party vendors to recruit for such trips; and
7. Absences caused by participation in privately planned trips shall be considered unexcused.

The Washington County Board of Education cautions any employee organizing a privately planned trip regarding an educator’s professional duties toward the students of the Washington County Schools, including the obligation not to use relationships with students for personal financial gain.

General

Any money collected by any school shall be documented by a written receipt.

The schools may receive funds collected from activities and for events held at or in connection with the school, including contracts with other schools for interschool events. To be included in this accounting are all monies collected from lunch rooms, athletics, entertainments, school clubs, fees, concessions, and all fundraising activities. Each principal shall determine the reconciliation method to be used for all events which require a ticket.¹

The purchase of items intended for resale for profit through the schools shall be subject to sales tax based on the purchase price to the vendor providing the service or item. Resale items not intended to generate a profit will follow the same approval process as fundraisers.²

FEES

School fees are to be kept to a minimum and may be expended only for the purposes for which they were collected. The school shall not require any student to pay a fee to the school for any purpose, except as authorized by the board. No fees shall be required of any student as a condition to attend the school or use its equipment.³ School fees shall be waived for students who receive free or reduced-price lunches.⁴ No student will be penalized for nonpayment of any school fee.

EXTENDED SCHOOL PROGRAM

Extended school funds shall be collected at the individual schools and receipted and deposited in the school bank account. The principal shall report the collections and pay the board by school check.⁵

FINES

A student will be held responsible for the cost of replacing any materials or property which the student loses or damages,⁶ including textbooks, library books, equipment, and buildings. All money collected as fines shall be placed in the system-wide school fund.

TUITION INCOME

Tuition collected from nonresident students shall be placed in the system-wide school fund.

RENTAL INCOME

The principal will collect and remit to the central office all money received for use of a particular school facility or other school property.

GRANTS

Grants for educational purposes made available by the state and/or federal government may be sought by the school system but only when the conditions of their availability are in harmony with the purposes and policies of the board and the laws of the state and county. Principals may apply for and receive grants, but funds must be recorded in a separate restricted fund account.⁷

COLLECTION OF FUNDS THROUGH ONLINE PAYMENT⁶

Approved district staff may utilize vendors approved through the CFO's office with the Director of School's approval for electronic transactions. The Director of Schools/designee shall determine when this type of transaction may be utilized on a case-by-case basis. At the individual school level, the principal shall oversee the collection of funds and submit a plan that includes the following:

1. Adequate supporting documentation for the electronic collection method including a plan to provide a total daily receipt summary;
2. Methods of providing receipts to payers;
3. Information on maintaining and inspecting any voided receipts; and
4. How daily electronic collections shall be reconciled with the total daily receipt summary and who will be assigned to complete this task.

Processing fees for these transactions shall not be charged on the school side.

The Director of School/designee shall establish adequate internal controls to ensure compliance with the *Tennessee Internal School Funds Manual*.

ROUNDING IN CASH TRANSACTIONS

Due to the discontinuance of the penny, rounding procedures shall be utilized in cash transactions. This applies to collections of all cash funds received by the district.

Cash transactions shall be rounded to the nearest \$0.05. The following rounding method shall be utilized:

- Amounts ending in \$0.01 or \$0.02 shall be rounded down
- Amounts ending in \$0.03 or \$0.04 shall be rounded up
- Amounts ending in \$0.06 or \$0.07 shall be rounded down

- Amounts ending in \$0.08 or \$0.09 shall be rounded up

The Director of Schools/designee shall monitor implementation to ensure compliance with accounting standards and state law.

General

Any employee who violates the terms of this policy shall be subject to disciplinary action, including but not limited to, suspension, dismissal, and/or referral for prosecution.

The Director of Schools shall be responsible for providing a copy of this policy to all school district employees.

DEFINITIONS

“Workplace” shall include any school building or any school premise; any school-owned or any other school-approved vehicle used to transport students to and from school or school activities; and off-school property during any school-sponsored or school approved activity, event, or function.

“Illegal drugs” shall include any narcotic drug, hallucinogenic drug, amphetamine, barbiturate, marijuana, or any other controlled substance as defined by federal law.²

“Unauthorized drugs” shall include, but are not limited to, inhalants; any designer, synthetic, derivative, analogous, or "look-alike" substances that are manufactured, designed, or intended to resemble and/or mimic the effects of illegal drugs; any legally prescribed drugs being used in a manner for which they were not intended or prescribed including, but not limited to, the use of prescription drugs prescribed for another individual; and any lawful substances that could result in impairment of physical or mental capacity that is threatening to the health or safety of the employee or others.³

“Alcohol” shall include, but is not limited to, spirits, liquor, wine, beer, and any liquid containing alcohol as defined by state and federal law.⁴

ALCOHOL & DRUG-FREE WORKPLACE

No employee while on or in the workplace shall unlawfully manufacture, distribute, dispense, possess, use, or be under the influence of any illegal or unauthorized drugs¹ or any alcohol.⁵

PHYSICAL EXAMINATION/SCREENING BASED UPON REASONABLE SUSPICION

Whenever the Director, or his/her authorized designee reasonably suspects that an employee’s work performance or on-the-job behavior may have been affected in any way by illegal drugs or alcohol or that an employee has otherwise violated this policy, Alcohol & Drugs in the workplace, the employee

may be required to submit a breath and/or urine sample for drug and alcohol testing as detailed in Policy 5.403 Drug & Alcohol Testing for Employees.
