a. Proposed Change to Article I Section 10 (Coaches Education Requirements) - submitted by Arlington High School

This proposal would remove the requirement for classified employees to take the NFHS Fundamentals of Coaching and NFHS Sport First Aid Courses.

d. Proposed Change to Article IV, Section 8 (TSSAA Sports Calendar) of the TSSAA Bylaws - submitted by Van Buren County High School

This proposal would increase the number of students who can receive individual instruction from their coaches in a given day. The proposal would keep the current numbers assigned to each sport, but would allow a coach to have multiple sessions in a day as long as the sessions were occurring at different times. The proposal would also allow multiple coaches to work with different groups of students on the same day, as long as the sessions take place in separate locations or in multiple sessions that take place at different times.

NFHS summary of TSSAA SMAC Meeting 10-1-2025

Wednesday, October 7th, 2026: Date for 2026 SMAC meeting

Heat:

The committee discussed developing a “best practices” document for member schools including who should be monitoring heat during practices and games and how often; what to do if heat rises or falls to a higher zone; etc. The committee asked the state office to survey member schools to see what time of day their fall sports typically practice in late summer/early fall when heat conditions are at their most extreme.

Head:

TN state law allows Physician’s Assistants with concussion training to sign off on Return to Play documents. TSSAA policy hadn’t included them in the past. The state office felt we should be in line with what state law allows. The committee discussed if Nurse Practitioners should be considered as well. This would require the law to be amended by the state legislature.

Health:

TSSAA is not aware of any legislative pressure or lobbying to allow chiropractors to perform and sign off on pre-participation physical exams. However, the state office has received inquiries from individual chiropractors. They are not approved by our bylaws. The committee discussed and agreed that this was not something that fell into their scope of practice, and therefore, should not be approved.

TSSAA SMAC has added Dr. David Sacks, PhD as a mental wellness professional. Dr. Sacks is a licensed clinical psychologist who specializes in stress, sports performance, and coping skills. He provided an overview of mental wellness as well as some resources for the group and state office to consider promoting and providing to our member schools, including the development of a Mental Wellness Emergency Action Plan.

TSSAA Best Practices:

The state office will begin working to expand our pre-game EAP meetings to all sporting events. Currently, we require it for all varsity football games.

The state office will work to develop one-pager guidelines for schools to use to rehearse their EAPs during practices.

Wrestling Weight Certification:

Member schools with wrestling requested a change to the weight certification window to move the first official date of certification from October 15 to September 15 to provide more flexibility for football players to get their certification done earlier in order to cut down on potential delays once football season has ended and assessor availability is an issue. A motion was made to approve the change and it was passed unanimously.

Division II Football Classification 2025-2029

- There will be a minimum of 12 schools in Class AAA. The remaining schools will be split evenly, by enrollment, between Class AA and Class A.
- When enrollments are gathered, each Division II football-playing school will be asked to declare to compete in Class AAA for the upcoming classification cycle.
- If 12 or more schools declare for Class AAA, they will all be placed in Class AAA.
- If fewer than 12 schools declare to participate in Class AAA, a **Success Rating Formula** will be used to select the number of schools necessary to meet the 12-school minimum. The highest rated schools that did not previously declare to be in Class AAA will be placed in Class AAA until the 12-team minimum is met.
- The **Success Rating Formula** will utilize data from the two most recently completed football seasons as of the date enrollments are gathered for the classification cycle. The formula shall be implemented as follows:
 - **Enrollment (80%)** Grade 9-12 co-ed normalized enrollment
 - **Postseason wins (10%)** - Number of wins beginning Week 12 of each season
 - **Region Win Percentage (5%)** - Percentage of games won of those used to determine region standings
 - **Region Scoring Margin (5%)** - Cumulative scoring margin in the games used to determine region standings
- **Region Crossover Games**
 - Each school in Class AAA will play one Class AAA opponent not in their region. These games will be home-and-home series with two year contracts.
- **Class Crossover Games**
 - If Class AAA has fewer than 14 schools, Class AAA schools will be paired with the largest schools in Class AA for an additional mandated game for each school. The largest Class AA school will be paired with the highest-rated Class AAA school, and so on down the list by enrollment, unless the matchup results in an East-West pairing. In these cases, the state office must make adjustments to the pairings so that all matchups are first geographically sound. These games will be home-and-home series with two-year contracts. If schools mutually agree to not play, then the contest will be considered a “no contest.”
- Class A schools will have the option to move to Class AA.
- Class A and Class AA will be divided into three regions (East, Middle, West)
- Class AAA will be divided into two regions (East, West)

The following 7 schools have not completed their membership for the 2025-26 school year:

1. Geeter Middle School - Missing dues and contract
2. Hanley Middle School – Has not started the process for 2025-26 and missing 2024-25 dues
3. Liberty Collegiate Academy (Middle School) - Only missing dues
4. Orchard Knob Middle School - Only missing contract
5. Redemption School of Music - They have completed everything for high school, nothing for middle school
6. Skyuka Hall Middle School - They have completed everything for high school, nothing for middle school
7. Templeton Middle Academy - They have only completed Membership Statement

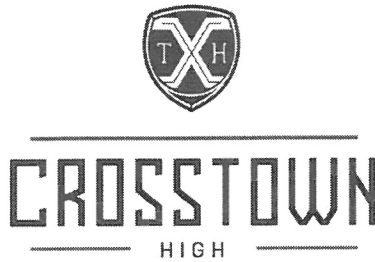

We have reviewed your request for release from the \$3,000 fee associated with your decision not to play the football game with Munford High School. We acknowledge the TSSAA's determination that a Covington student was the subject of a violation of the TSSAA Recruiting Rule by Munford High School. However, it is important to note that the occurrence of one school being found in conflict with another, even due to rule violations, is an unfortunate but not uncommon scenario in interscholastic athletics.

Proposal: Expanding Opportunities for Tennessee High School Basketball Teams in NCAA Live Recruiting Periods

Overview

This proposal advocates for allowing Tennessee boys' high school basketball teams to participate in both NCAA live recruiting periods. The goal is to maximize recruitment exposure for student-athletes within our state, ensuring they are not placed at a competitive disadvantage compared to athletes in neighboring states.

Rationale

1. Direct Impact on Student-Athletes

- Exposure during NCAA live periods is critical for recruitment. It only takes one viewing by the right college coach to change a student-athlete's future.
- Restricting Tennessee high school teams to only one live period limits opportunities for players with college potential.

2. Equity with Out-of-State Athletes

- Currently, BCAT provides opportunities for teams from other states to participate in Tennessee events, which positively impacts their athletes.
- However, Tennessee athletes are disadvantaged by being restricted from the second live period and from competing on Sunday during the first live period. This creates unequal recruiting exposure.

3. Retention of Talent in Tennessee

- Neighboring states host highly attended live events during the second recruiting period. When Tennessee athletes cannot participate, they lose valuable visibility.
- As a result, some student-athletes are transferring out of state or enrolling in unsanctioned schools that offer access to these opportunities, weakening Tennessee's basketball programs overall.


Benefits of Allowing Participation in Both Live Periods

- Increased visibility for Tennessee athletes in front of college recruiters.
- Level playing field with athletes from surrounding states.
- Strengthened Tennessee high school basketball programs by reducing the incentive for players to leave the state.
- Enhanced credibility and reputation for BCAT and TSSAA in advocating for student-athlete advancement.

Conclusion

Allowing Tennessee high school teams to participate in both NCAA live recruiting periods, as well as removing restrictions on Sunday competition during the first live period, is essential for ensuring fairness and maximizing opportunities for student-athletes. This adjustment directly impacts nearly every high school program with college-level players and helps Tennessee retain and develop its basketball talent.

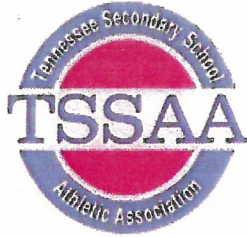

This cause came for hearing on the written Petition to Expunge Records of Conviction Pursuant to T.C.A. §40-32-101(g) and the entire record, from all which the Court finds that:

1. The statute authorizes the subject conviction to be expunged.
