1 Students residing outside the boundaries of the school system may attend schools within the school  
 2 system under the following conditions. The Morgan County Board of Education has adopted the BEP  
 3 Standards for class size. Principals may accept out-of-county students as long as BEP Standards and  
 4 the following priorities for student acceptance into the schools are met:

- 5 1. They must be approved by the director of schools and school principal.<sup>1</sup>
- 6 2. If a class size is exceeded, students will have to return to their home district on a last  
 7 in first out basis..
- 8 3. They must pay a tuition fee of \$100.00 per semester per student.<sup>2</sup>
- 9 4. Non-resident students must make application at least two weeks prior to the first day  
 10 of school.
- 11 5. Students who become residents of the school system will be refunded any unused  
 12 portion of the tuition on a pro-rata basis.
- 13 6. When payment is not made on all or any part of the required tuition of a previous year,  
 14 the student(s) shall be excluded from future attendance until all prior and current  
 15 tuition is paid.
- 16 7. Any dependent of a Morgan County Schools employee, who lives outside Morgan  
 17 County School System, shall be eligible to attend the school of their parent's  
 18 employment. Full time employees of Morgan County Schools will have tuition  
 19 waived. Parent volunteers do not meet this requirement.<sup>4</sup>
- 20 8. Request from students from adjoining states to attend school shall be considered on a  
 21 case-by-case basis.<sup>3</sup>
- 22 9. Out-of-county students, who become a documented behavior and/or attendance  
 23 problem, will be transferred back to their assigned attendance area.
- 24 10. Bus transportation will not be provided for out-of-county students

1 *General*<sup>1</sup>

2 Each year, the Director of Schools/designee shall review the number of spaces available in each school  
 3 by grade, class, and program levels. This information shall be posted on the district’s website along with  
 4 the dates of the district’s open enrollment period. The open enrollment period shall last for thirty (30)  
 5 days and information about the number of seats available shall be posted for at least fourteen (14) days  
 6 prior. The Director of Schools/designee shall reserve a reasonable number of enrollment spaces at each  
 7 school to account for the enrollment of zoned students, siblings of students, and students who have a  
 8 parent/guardian employed at the school.<sup>2</sup>

9 During the district’s open enrollment period each year, a parent/guardian may request that his/her child  
 10 attend a school within the district other than the one to which the child is zoned. The Director of  
 11 Schools/designee shall review such requests, and if adequate space is available, grant such transfers. If  
 12 the number of requests exceeds the number of available spaces, the Director of Schools/designee shall  
 13 implement a lottery to fill the available spaces.

14 The open enrollment process shall be completed before other nonresident transfers are approved.

15 **POST ENROLLMENT**<sup>1</sup>

16 Once accepted, the student shall provide his/her own transportation to and from the school. The student  
 17 must maintain satisfactory attendance, behavior, and effort to remain in the new school.

18 **CHANGE IN RESIDENCE**<sup>1</sup>

19 Students whose families transfer their residence to another school area after the first month of school  
 20 may complete the school year at their former school. Students who present evidence that they will move  
 21 during the school year and who desire to enroll in a new school in the new area may do so with prior  
 22 written request for a change of school area.

23 **[NOTE: Not effective in the event of a federally mandated desegregation order.]**<sup>3</sup>

## Documentation Supporting Request for Removal

**6.306.1**

1 If a student repeatedly or substantially interferes with the  
2 learning environment, the teacher may submit a written request to  
3 the principal/designee to remove the student from the teacher's  
4 classroom. The written request shall include the following  
5 documentation to demonstrate that the teacher has previously:

- 6 1. Taken action to address the student's disruptive behavior;
- 7
- 8 2. Provided consequences for the student's disruptive behavior;
- 9
- 10 3. Conducted an oral conference, either by a documented telephone conversation or an in-person  
11 discussion, with the student's parent/guardian regarding the student's disruptive behavior;
- 12
- 13 4. Provided an opportunity for school counseling or other support services deemed appropriate to  
14 address the student's disruptive behavior;
- 15
- 16 5. Developed and implemented a plan to improve the student's behavior in a conference with the  
17 student; and
- 18
- 19 6. Issued a disciplinary referral to the principal to address the student's disruptive behavior.

1 *General*

2 The Board shall provide for a system-wide testing program which shall be periodically reviewed and  
3 evaluated. The purposes of the program shall be to:

- 4 1. Assist in promoting accountability;
- 5
- 6 2. Determine the progress of students;
- 7
- 8 3. Assess the effectiveness of the instructional program and student learning;
- 9
- 10 4. Aid in counseling and guiding students in planning future education and other endeavors;
- 11
- 12 5. Analyze the improvements needed in each instructional area;
- 13
- 14 6. Assist in the screening of students with learning difficulties;<sup>1</sup>
- 15
- 16 7. Assist in placing students in remedial programs;
- 17
- 18 8. Provide information for college entrance and placement; and
- 19
- 20 9. Assist in educational research by providing data.<sup>2</sup>

21 The Director of Schools shall be responsible for planning and implementing the program which includes:

- 22 1. Determining specific purposes for each test;
- 23
- 24 2. Selecting the appropriate test to be given;
- 25
- 26 3. Establishing procedures for administering the tests;
- 27
- 28 4. Making provisions for interpreting and disseminating the results;
- 29
- 30 5. Maintaining testing information in a consistent and confidential manner; and
- 31
- 32 6. Ensuring that results are obtained as quickly as possible, especially when placement in a special  
33 learning program might be necessary.

1 State-mandated student testing programs shall be undertaken in accordance with guidelines published  
2 by the State Department of Education.<sup>3</sup>

### 3 **WEIGHTING TCAP SCORES**

4 TNReady<sup>4</sup> and EOC<sup>5</sup> scores shall be included in students' final grades as follows:

- 5 1. Grades 3-5 – 10%
- 6 2. Grades 6-8 – 10 %
- 7 3. Grades 9-12 – 15%

8 The MORGAN COUNTY School System shall use the following methodology: [**cube**  
9 **root methodology.**]

10 The Director of Schools may exclude these scores from students' final grades if results are not received  
11 by the district at least five (5) instructional days before the end of the course.<sup>4,5</sup>

### 12 **INTEREST INVENTORIES AND CAREER ASSESSMENTS<sup>6</sup>**

13 Interest inventories shall be made available to middle schoolers. These will include assessments such as  
14 the Kuder assessment, Myers-Briggs Type Indicator, the ASVAB, or the College Board Career Finder.

15 Career aptitude assessments shall be administered to 8<sup>th</sup> graders in order to inform the student's high  
16 school plan of study. Upon receiving the results from these assessments, the school shall provide students  
17 with information on any available career and technical education opportunities in which the student is  
18 eligible to participate in.

### 19 **TESTING INFORMATION AND PARENTAL CONSENT**

20 Any test directly concerned with measuring student ability or achievement through individual or group  
21 psychological or socio-metric tests shall not be administered by or with the knowledge of any employee  
22 of the district without first obtaining written consent of the parent(s)/guardian(s).<sup>2</sup>

23 Results of all group tests shall be recorded on students' permanent records and shall be made available  
24 to appropriate personnel in accordance with established board policies.<sup>7</sup>

25 No later than July 31<sup>st</sup> of each year, the Board shall publish on its website information related to state  
26 and board mandated tests that will be administered during the school year. The information shall  
27 include:<sup>8</sup>

- 28 1. The name of the test;
- 29
- 30 2. The purpose and use of the test;
- 31
- 32 3. The grade or class in which the test will be administered;
- 33

- 1 4. The tentative date or dates that the test will be administered;  
2  
3 5. The time and manner in which parent(s)/guardian(s) and students will be notified of the results  
4 of the test;  
5  
6 6. How parent(s)/guardian(s) can access the questions and answers on their student's state-  
7 required tests; and  
8  
9 7. If a board mandated test, how the test complements and enhances student instruction and  
10 learning and how it serves a purpose distinct from state-required tests.
- 11 Testing information shall also be placed in student handbooks or other school publications that are  
12 provided to parent(s)/guardian(s) on an annual basis.

1 *General*

2 A student shall not engage in conduct which causes the disruption or interference with the operation of  
 3 the school while on school property, in school vehicles or buses, or at school-sponsored events,  
 4 whether on or off campus. The student shall not urge other students to engage in such conduct.

5 Employees are authorized to take reasonable measures to establish appropriate school behavior and  
 6 have the authority to control the conduct of any student while under the supervision of the school  
 7 district.<sup>1</sup>

8 A student may receive disciplinary action ranging from verbal reprimand to suspension and/or expulsion  
 9 depending on the severity of the offense and the student’s prior record.<sup>2</sup>

10 **REMOVAL OF STUDENT<sup>3</sup>**

11 If a student repeatedly or substantially interferes with the learning environment, the teacher may  
 12 submit a written request along with the required documentation to the principal/designee to remove the  
 13 student from the teacher’s classroom. The student will be given notice of the rationale for the request  
 14 as well as the opportunity to offer an explanation.

15 The principal/designee will investigate the request and make a decision regarding the student’s  
 16 placement. The principal will notify the teacher as to his/her decision.

17 If a teacher abuses or overuses the student removal process, the principal/designee shall address the  
 18 abuse or overuse with the teacher and may require the teacher to complete additional professional  
 19 development to improve the teacher’s classroom management skills.

20 *Appeal Process*

21 If the teacher’s request for removal is denied, he/she may file an appeal with the Director of  
 22 Schools/designee. He/she will review the teacher’s request for removal as well as the decision of the  
 23 principal/designee and make a determination as to the student’s placement.
